Ernst Stiefel Symposium on the Nuremberg Trials



Get Free Tax Help




Professor Richard Beck testified before the House Ways and Means Committee on March 24 in hearings to amend the taxpayer Bill of Rights.

Professor Arthur Leonard spoke on AIDS and employment discrimination law at a program entitled "AIDS/HIV: Legal Challenges for the '90s," presented by the Suffolk University Law School Advanced Legal Studies Program in Boston on March 16. His letter to the editor about Henry Roth's new novel, *A Diving Rock on the Hudson*, was published in the *New York Times Book Review* on March 18.

Professor Jethro Lieberman was quoted about the importance of writing skills in the legal field in the March 20, 1995 U.S. News & World Report, "America's Best Graduate Schools" issue. The article was entitled "Combating Legalese: Law Schools are Finally Learning that Good English Makes Good Sense."

On March 6 and 7, Professor Nadine Strossen lectured at Elgin Community College and Quincy University, both in Illinois, in honor of Women's History Month. On March 7, she addressed the National Association for Women Journalists in Chicago. She spoke at a book forum sponsored by the Freedom Forum in Alexandria, VA, on March 8; the event will be televised on PBS. On March 9, she debated University of Calgary Law Professor Kathleen Mahoney at the 92nd Street Y in N.Y.C. on hate speech and pornography (moderated by WNYC's Leonard Lopate and televised by Canadian Broadcasting Company). Professor Strossen's article, "Civil Liberties," was published in 4 George Mason University Civil Rights Law Journal 253-273 (1993-94). She served as a narrator for "The Arguments on Abortion," live recordings and transcripts of eight oral arguments on reproductive rights of the May It Please the Court audio cassette series (edited by Stephanie Guitton and Peter

Irons), along with Congresswoman Eleanor Holmes Norton and NYU Law Professor Sylvia Law. On March 10 at Columbia University, she was a panelist at a conference on "Self-Regulation and Ownership Regulation in TV: the American Experience," sponsored by the Columbia Institute for Tele-Information and the Bertelsmann Foundation. She spoke at the "Banners" cultural program on March 16 at McNeese State University in Lake Charles. Louisiana in a dialogue with Chief Judge Richard Arnold of the U.S. Court of Appeals for the Eighth Circuit on "Language, Gender, Power, and the Law." She also gave the keynote address at the March 18 Third Annual Symposium on Women and the Law at Tulane Law School in New Orleans, Louisiana. Professor Strossen was the subject of the March 5 San Francisco Examiner article, "Speaking Out Against the New Prissiness."



WAITLIST FOR TRIAL ADVOCACY:

Beginning Thursday, March 30, at 5:30 pm, students who did not request (during preregistration) or pick up (between March 20 & 24) a lottery number for Trial Advocacy will be able to submit their names to a first-come/first-serve waitlist in the Registrar's Office. The waitlist will remain available for signatures until April 5 at 7:00 pm. Students who participated in the preregistration lottery but were not offered a spot need not go to the Registrar's Office.
