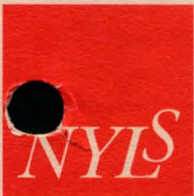

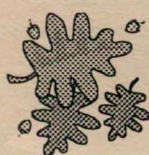

Congratulations to Moot Court competitors Preeti Singh, Karen Formisano, and coach Marc Lewis, the National Semi-finalists at the University of Connecticut's Insurance Law Moot Court Competition. Ms. Singh also won the National Best Oralist Award at the competition. The last time NYLS Moot Court competed in Connecticut, 1991, it also was the National Semi-finalist, and the time before that, 1989, NYLS again was National Semi-finalist and again won the National Best Oralist award.

Faculty Activities

Professor Karen Gross conducted a training session for bankruptcy judges in San Diego for the Federal Judicial Center on November 2-4. The topic was "Corporate Pre-Bankruptcy Planning."

Con Edison elected **Professor Ross Sandler** and Washington D.C. attorney Angus Macbeth as the

two environmental legal experts forming its Environmental Quality Review Board. The Board, established on November 3, 1994, will conduct a management review of the environmental function as it is practiced at Con Edison.

On October 31, **Professor Nadine Strossen** was filmed for a British television documentary on pornography that will be aired in early 1995. On November 2, she debated former U.S. Attorney General Ed Meese at Vanderbilt University in Nashville, Tennessee, on the topic "Crime in America: Is the Justice System Fair?" She lectured on current free speech controversies on November 3 at Gustavus Adolphus College in St. Peter, Minnesota. And she spoke in Richmond, Virginia, on November 5 about gay/lesbian rights at the Annual Bill of Rights Celebration of the ACLU of Virginia. The celebration honored the ACLU's client Sharon Bottoms, who had her young son removed from her custody because she is living with her lesbian partner.
