



# Faculty Activities

As in the past, Adjunct Professor Judge Frederic S. Berman '51 performed a dozen weddings on Valentine's Day this year atop the Empire State Building. Three of the ceremonies were telecast live nationwide on the FOX network morning program "After Breakfast." He and Appellate Division Presiding Justice Francis T. Murphy are co-chairmen of the 1951-52 Class Reunion to be held in May at the law school.

On February 18, Professor Nadine Strossen gave a talk on "Civil Liberties Dangers of Genetic Screening and Databases" at the 1997 Annual Meeting of the American Association for the Advancement of Science in Seattle, Wash. She was also filmed for TV and radio shows and an educational video about this issue. On February 19, she was interviewed by Swedish Public Radio about the free speech and feminist issues surrounding the movie "The People vs. Larry Flynt," which is about to open in Sweden. On February 19, she participated in a panel discussion sponsored by NYLS's Italian-American Law Student Association concerning the independence of the judiciary. Her column, "A New Kind of Judicial Activism," was published in the February 20, 1997 issue of the E-Zine Intellectual Capital.

**Professor Ruti Teitel** was a speaker at a symposium titled "Human Rights on the Eve of the next Century" held at Fordham University School of Law on February 28. She participated in a panel titled "Beyond Vienna & Beijing: Human Rights in Theory."

## NYLS TO HOST WAGNER COMPETITION

The country's largest entirely schoolsponsored moot court competition -- the 21st Annual Robert F. Wagner, Sr. National Labor Law Moot Court Competition -- will take place at NYLS March 20 - 23.

The Wagner Competition is named for the NYLS alumnus and United States Senator from New York and addresses timely issues in both labor and employment law. This year's competition issues are whether disparate impact is a cognizable claim under the Age Discrimination and Employment Act and whether a union member must adhere to a binding arbitration decision.

This year, over 40 law schools from across the country will argue before more than 100 judges. The competition judges will consists of NYLS alumni and faculty as well as other distinguished judges, professors and attorneys in the labor and employment law field. The final round bench will include John Raudabaugh, Esq., Daniel Silverman, Esq. (NLRB) and Spencer Lewis, Jr., Esq. (EEOC). The preliminary rounds on **Thursday and Friday, March 20 and 21**, and the advanced rounds on **Saturday, March 22**, will take place in various rooms throughout the school. The final round will take place in the Ernst Stiefel Reading Room on **Sunday, March 23**.

## FINANCIAL AID FINAL REMINDER

The deadline for completing your application to receive grant-in-aid assistance for 1997-98 from NYLS is <u>April 15</u>. Applications for NYLS grant-inaid received or completed after the deadline will be considered only to the extent that funds remain available. Since a late application may result in a reduced, or no award, it is in your best interest to complete your application as soon as possible. To meet the April 15th deadline, we recommend that the Free Application for Federal Student Aid (FAFSA) and the Need Access diskette be completed and mailed for processing by <u>March 15</u>.

Please be aware that applicants for grant-in-aid assistance must complete a Need Access application diskette, which can be completed on any IBMcompatible personal computer. Applicants for NYLS grant-in-aid funds must complete all sections of the diskette, including the parents' questionnaire, and mail it in the mailer provided to The Access Group, the Need Access data processor. The diskette must be obtained by calling The Access Group at 1-800-282-1550. The program can also be downloaded from The Access Group's home page at www.accessgrp.org.

Applicants for federal aid only are not required to file the Need Access diskette. However, recipients of merit-based scholarships that are renewable on the basis of academic performance are encouraged to complete the need-based application materials by the April 15 deadline in the event that the merit award is not renewed for 1997-98.
