FINANCIAL AID

APPLICATION REMINDER

The deadline for completing your application to receive grant-in-aid assistance for 1997-98 from NYLS is April 15. Applications for NYLS grant-in-aid received or completed after the deadline will be considered only to the extent that funds remain available. Since a late application may result in a reduced, or no award, it is in your best interest to complete your application as soon as possible. To meet the April 15th deadline, we recommend that the Free Application for Federal Student Aid (FAFSA) and the Need Access diskette be completed and mailed for processing by March 15.

Please be aware that applicants for grant-in-aid assistance must complete a Need Access application diskette, which can be completed on any IBM-compatible personal computer. Applicants for NYLS grant-in-aid funds must complete all sections of the diskette, including the parents' questionnaire, and mail it in the mailer provided to The Access Group, the Need Access data processor. The diskette must be obtained by calling The Access Group at 1-800-282-1550. The program can also be downloaded from The Access Group's Home Page at www access grap org

Only applicants for federal aid are not required to file the Need Access diskette. However, recipients of merit-based scholarships that are renewable on the basis of academic performance are encouraged to complete the need-based

application materials by the April 15 deadline in the event that the merit award is not renewed for 1997-98

Faculty Activities

Professor Carlin Mever's book review of No. Mercy: How Conservative Think Tanks and Foundations Changed America's Social Agenda, by Jean Stefancic and Richard Delgado, was published in the New York Law Journal on February 3. She was also quoted in The Wall Street Journal on January 29 concerning the Appellate Division's decision that Comex, a division of the New York Mercantile Exchange, is a place of public accommodation covered by New York State Human Rights Law and hence could be sued for its role in condoning a sexually hostile environment that allegedly led to harassment of and injury to a female trader.

Professor Michael Perlin's article, "The Executioners Face is Always Well-Hidden': The Role of Counsel and the Courts in Determining Who Dies," was just published as part of a minisymposium on psychiatry, the death penalty and professionalism in the New York Law School Law Review, volume 41, page 201 (1996). He was selected as a member of the National Advisory Board of a State Justice Institute project that will develop and publish a benchbook for state court judges on psychiatric and psychological evidence and testimony. The Rocky Mountain News ran The New

York Times story quoting him on the Michael Irvin case. The Albany Times-Union published an interview quoting him on the use of the insanity defense in infanticide cases on Sunday, February 9. The following Sunday, The Washington Post published his brief reminiscence of attending the Martin Luther King, Jr. "I Have a Dream" speech in August 1963. On Tuesday, January 20, he was interviewed on National Public Radio's morning edition on the "Guilty but Mentally III" verdict. Finally, he was one of the faculty members for an online CLE seminar on the ADA presented on Counsel Connect.

On February 3 and 4, Professor Nadine Strossen spoke in Denver and Boulder, Colo., including a presentation to the faculty at the University of Denver College of Law. On February 8, she gave a lecture on "The First Amendment and the Internet" to the Annual Convention of the First Amendment Lawyers Association in San Jose, Costa Rica. Two recently published books include chapters by her: Hate Speech on Campus: Cases, Case Studies, and Commentary (Northeastern University Press 1997); and Contemporary American Speeches: A Sourcebook of Speech Forms and Principles (Kendall/Hunt Publishing Co. 1997).
