Faculty Activities

In 1996 Professor Jim Simon's book The Center Holds was published in paperback by Touchstone/Simon & Schuster. His chapter on Justice William O. Douglas (originally presented as a paper in a 1994 conference on the Warren Court at the University of Tulsa Law School) has been published by Oxford University Press in a book titled The Warren Court: A Retrospective. His essaybook review on biographies of Justices Hugo Black and Lewis Powell Jr. has been published by the Stanford Law Review. Professor Simon has also been elected to the Board of Trustees of Hobart and William Smith Colleges.



On January 28, Professor Nadine Strossen addressed the Jacksonville Women's Lawyers' Association in

Jacksonville, Florida about current women's rights issues. On that same date, she gave a lecture at Florida Coastal School of Law in Jacksonville. On January 30, she moderated an all-day Symposium sponsored by the NYLS Journal of Human Rights on issues raised by all-female public education. She was also filmed for a WBIS-TV segment on "The Singing Experience" (focusing on her cabaret "career"). On February 2, she was a guest on CNN's "Crossfire," discussing First Amendment issues raised by "The People vs. Larry Flynt." She was also the guest on "The Pleasure Dome," a radio show in Atlanta, hosted by sex therapist Roger Libby, discussing First Amendment issues concerning sexuallyoriented expression.
