## **HOLIDAY TOY DRIVE**



The <u>DEADLINE</u> is February 14, 1997, however, students are encouraged to apply as soon as possible, as hiring decisions will be made on a rolling basis.

#### • New York Lawyers for the Public Interest (NYLPI) - Summer Internship

NYLPI is a not-for-profit public interest law firm with summer internship openings for first and second-year law students. Students work one-onone with the attorneys, attend meetings and court appearances, and are fully integrated into the life of the office. Student Intern responsibilities include working on complaints, briefs and motions, conducting client interviews and helping staff attorneys respond to telephone requests for legal advice. NYLPI does not have funding to pay student salaries, but it does meet the matching requirements of fellowships or work-study programs, where possible.


