Your application should include 3 resumes, 3 copies of your writing sample, and your Judicial Externship Preference Form. **Be sure to staple your** writing samples and paper clip your resumes to your writing samples.

As the Judicial Externship Packet indicates, students applying for Federal and State

Appellate Externships must interview with members of the NYLS Placement and Clerkship Committee. Interviews will take place on January 21 and 22, 1997. You can sign up for an interview slot when you submit your application in Room B107.

SECURITY AND SAFETY

TIS THE SEASON TO BEWARE OF PICKPOCKETS

The holiday season provides many opportunities for the pickpocket. Here are some tips on how to keep your holiday crime free:

• Carry your handbags over the shoulder and close to the body, not dangling by the handle. A wallet should be placed at the bottom or within a zippered compartment of your bag. Consider dividing a portion your money between clothing pockets and a handbag or briefcase.

• Carry your wallet in an inside coat or front pant pocket.

• Avoid overloading your arms with packages or other items.

• Stay alert and be aware of what is going on around you, especially in crowded settingswalking along streets, in elevators, on staircases, in stores and while riding on mass transit.

• Pickpockets often work with the assistance of others. Be alert of loud and disruptive outbursts, and of being stopped by strangers seeking directions. These actions have been used by pickpockets to divert your attention from an accomplice.


ATTENTION FEBRUARY 1997 GRADUATES

On Tuesday, November 19th, **Professor Emeritus B.J. George** was awarded a *kunsantozuihosho* (*kunsho*) decoration by the Japanese government, in Tokyo. The decoration was recommended by former students and colleagues.

Professor Karen Gross had dinner with President Clinton and bankruptcy professionals at the home of William Brandt on September 17.

On November 21, **Professor Randolph Jonakait** gave a talk on "Objections, Limiting Instruction, and the Doctrine of Completeness" for the New York State Bar Association's program, "Practical Evidence." Professor Jonakait has been appointed a member of th ABA Committee on Law and the Regulation of Scientific Research.

On November 14, **Professor Arthur Leonard** spoke on "Homosexuality and the Law" for a sociology class at Hunter College of the City University of New York taught by Professor Yaffa Schlesinger. On November 26, he was quoted on confidentiality issues surrounding HIV status in an article titled "Confidentially Speaking" in the national lesbian and gay magazine *The Advocate*.

Professor Carlin Meyer wrote a review of the book A Guide to America's Sex Laws by Richard A. Posner and Katherine B. Silbaugh, for the New York Law Journal. The review was published on November 8.

Professor Michael Perlin visited the University of Iowa last week as the Ida Beem Distinguished Visiting Professor at the College of Law and School of Medicine. He presented a Grand Rounds talk to the Medical School (on development sin the law of competency to waive counsel and competency to plead guilty), and a special lecture to the law school on the insanity defense. This latter paper -- "The Borderline Which Separated You From Me': The Insanity Defense, the Authoritarian Spirit, the Fear of Faking, and the Culture of Punishment -- will be published as the lead article in an upcoming issue of the Iowa Law Review. While at the university, he also presented a lunchtime talk to the law faculty (on other insanity defense topics), taught the Law and Psychiatry class at the law school, and spoke to faculty in the forensic psychiatry, child psychiatry and pediatrics departments at the medical school about recent legal developments related to those areas of specialty practice.

On November 13, **Professor Richard Sherwin** appeared on "Inside the Law" a nationally syndicated public television series, hosted by Jack Ford. The subject was the interconnections between law and film. Filmmaker Alan Pakula (*To Kill A Mockingbird*, *Presumed Innocent*, *The Pelican Brief*,) also appeared on the program.

On November 11, Professor Nadine Strossen gave two lectures at Harvard University. On November 13, she lectured at the University of Southern Indiana in Evansville, Indiana. On November 14, she gave the keynote address at the Annual Banquet of the ACLU of Pennsylvania. She was also interviewed on Radio America's "Dateline Washington" program about the ACLU's constitutional challenge to the California antiaffirmative action ballot initiative. On November 15, she gave two talks in Chicago, sponsored by the ACLU of Illinois. On November 16, she spoke at the Annual Awards Dinner of the ACLU of New Jersey in New Brunswick. She received that organization's Roger N. Baldwin Civil Liberties Award, along with John J. Gibbons, retired Chief Judge of the U.S. Court of Appeals for the Third Circuit, and New Jersey Congressman Donald Payne. On November 18, she was taped for two upcoming "Freedom Speaks" programs, to be aire on PBS-TV, on "Fashion, Advertising, and Media Responsibility," and "Kids, Clothes, and Free Expression." On November 20, she debated Julius Chambers, former Director-Counsel of the NAACP-LDEF, for an audience of New York City high school students, in a program sponsored by the Board of Education. The topic was hate speech codes on college and university campuses. On November 21, she spoke at a reception for the ACLU of Southern California in Los Angeles, and was a guest on CBS TV's "Late Late Show" with Tom Snyder.

On November 12, Professor Ann F. Thomas spoke about prospects for tax policy change in the second Clinton administration at the Annual National Economic Policy Forum of the Women's Economic Round Table in New York. This year's program focused on trade, taxation and the Federal Reserve System. The other panelists were the Honorable Nancy Hays Teeters, former Federal Reserve Governor and the Honorable Barbara Hackman Franklin, former Secretary of Commerce. Elizabeth E. Bailey, Professor of Public Policy and management at the Wharton School, University of Pennsylvania, moderated the forum which also included Constance Mitchell Ford, Economic Edit of the Wall Street Journal and MaryAnn Busso of Bloomberg Business News.
