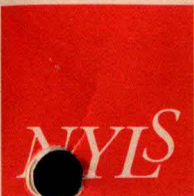

## **CABLE T.V. FRANCHISE SEMINAR**

The Communications Media Center and the Center for New York City Law are hosting a seminar, titled "Cable T.V. Franchise Renewals: Business as Usual or a Time for New Priorities?" on **Thursday, November 21** at 6 p.m. in The Dining Room.

The seminar will examine cable franchise renewals from historical and legal perspectives. The panel of experts will detail how changes in technology and the marketplace are affecting the competitive landscape and discuss how issues such as franchise fees and rates, PEG-channels and leased access are changing the competitive environment.

The guest speakers are: David Bronston, Lowenthal, Landau, Fischer & Bring; Dr. Charles Eldering, Director of Advanced Systems Engineering, General Instruments Corp.; Eric Lane, the Eric J. Schmertz Distinguished Professor of Public Law and Policy Service, Hofstra University, and NYLS Adjunct Professor; Robert Perry, Adjunct Professor, Interactive Telecommunications, NYU; Elaine Reiss, General

Counsel, NYC Dept. of Information Technology and Telecommunications; Lawrence White, Professor, Stern School of Business, NYU; and NYLS Professors Michael Botein and Ross Sandler.

## Faculty Activities

On November 3, **Professor Nadine Strossen** was taped for a PBS educational videotape series for teenagers, "Ethical Choices: Individual Voices," discussing young people's rights and responsibilities. On November 4, she lectured at NYU Law School's Public Interest Forum and on November 5 she led a discussion group with NYU Law students in public interest programs. On November 6 she was taped for National Public Radio's "Bridges" program, in a debate with Judge Robert Bork about issues raised in his new book, *Slouching Towards Gomorrah*. On November 7, she delivered the keynote address at the National Youth Leadership Forum on Law and the Constitution in Washington, D.C. She also spoke in the Law Clerks' Speakers Program at the United States Courthouse in Washington, D.C. On November 7 and 8, Professor Strossen gave three lectures at Dutchess Community College in Poughkeepsie, NY. The newly published book *Advocacy in the Classroom: Problems and Possibilities* (St. Martin's Press) includes her chapter, "First Amendment and Civil Liberties Traditions of Academic Freedom."



Over the summer, **Professor Lung-chu Chen** was elected to the Executive Council of the Society for the Policy Sciences. The book, *The Establishment and Development of a Constitutional Culture in Taiwan*, which he edited and was a contributor to, was published by the Avanguard Press in Taipei, Taiwan. At the annual meeting of the North America Taiwanese Professors' Association (NATPA) held on August 2-4 in Southern California, he spoke on "The Rule of Law and Democracy." On September 12, he lectured on Taiwan-China-U.S. relations (including human rights and Hong Kong issues) at the New York State Bar Association's continuing legal education program on "Legal Issues in Doing Business in China." Remarks from his September 16 speech, "Prospects for Taiwan's Membership in the United Nations" at the Taiwan Roundtable, in the Hart Senate Building in Washington, D.C., were reported by National Public Radio and other media. On September 18, he was interviewed by The Voice of America regarding Taiwan-China-U.S. relations. He was also interviewed by *The Los Angeles Times* concerning the controversy of Diaoyu islets (Senkaku Islands) involving Taiwan, China, and Japan. On October 25, he served as a commentator addressing a wide range of human rights issues at the Policy Sciences Annual Institute held at Yale Law School. On November 14, he spoke at a panel on "Nationalism,

Intercommunal Conflict/Ethnic Strife and the Rule of Law: A Global Perspective," held at the House of the NYC Bar Association. His recent publications include: "Taiwan, China, and the United Nations," in *The International Status of Taiwan in the New World Order: Legal and Political Considerations* (189-206); "Remembering the Past as a Guide for the Future: The 'One China' policy impairs Taiwan's March Toward the United Nations," in the *Liberty Times* (Taiwan and USA), on September 16; and "The Admission of Taiwan to the United Nations and the so-called 'One China' Policy" in the *Liberty Times*, on September 29.



**Professor Lenni Benson** was a speaker at the 29th Annual Immigration and Nationality Law Institute sponsored by the Practising Law Institute. She lectured on recent developments in the law of political asylum and the impact of the Illegal Immigration Reform and Immigration Responsibility Act of 1996. Professor Benson also assisted Gerald Neuman of Columbia Law School in the preparation of an *amicus curiae* brief to the Ninth Circuit Court of Appeals concerning the continuing availability of *habeas corpus* review of deportation orders after the passage of the Anti-terrorism and Effective Death Penalty Act of 1996. Twenty-six law professors signed onto the *amicus* brief. Last June, Professor Benson addressed the annual national conference of the American Immigration Law Professors held in Phoenix, Arizona. She spoke on political asylum and withholding of deportation.



**Professor Ruti Teitel** participated in a conference on the Bosnian peace process entitled, "A Year After Dayton: Has the Bosnian Peace Process Worked?" She also made two guest appearances on Court T.V.: one on October 16 as a commentator on the Bosnian Tudic Trial and another on October 23 as a guest war crimes commentator on a special show with the former ambassador to Yugoslavia.



**Adjunct Professor Seymour I. Feig** has been invited to lecture at New York University Law School on November 21 on the subject of motion pictures. The subject will be "The Art and Science of Packaging, Producing and Distributing Motion Pictures, Then and Now."

## **REMINDER OF UPCOMING DEADLINES**

- **Department of Housing and Urban Development (HUD) - Legal Intern Program**

HUD's Office of General Counsel (OGC) Legal Honors Intern Program for graduating law students serves as the Department's only recruitment program for new attorneys.

The General Counsel is the chief law officer of the Department and principal legal adviser to the Secretary and staff of HUD. OGC provides legal opinions, advice and services with respect to all departmental programs and activities. OGC has primary responsibility for the development of HUD program regulations and assists in the development of HUD programs and policies. The DEADLINE is November 30.

- **Charles H. Revson Law Students Public Interest (LSPIN) Fellowship Program**

This program will provide summer grants for first and second-year law students to work with public interest organizations in the New York metropolitan area. It is designed to give qualified and committed law students the opportunity to explore career opportunities in public interest law and public service. Approximately 42 grants of \$3,250 will be awarded to students attending law school in New York and New Jersey for ten weeks of full-time work during the summer of 1997. The application DEADLINE is December 3.

- **Public Interest Law Initiative (PILI) - Summer Internship Program**

Application DEADLINE is January 13, 1997.

- **Puerto Rican Legal Defense and Education Fund (PRLDEF) Scholarships**

Application DEADLINES are January 31, 1997.

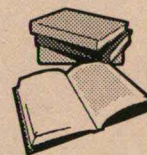
- **New Jersey Summer Public Interest Legal Intern Program**

## **FROM THE LIBRARY**



### **WESTLAW CLASSES**

Westlaw Training Classes for first-year students will be held in the library Westlaw Room (L311) from **Monday, November 18** through **Tuesday, December 3**. All first-year students are required to attend a class as assigned by the Legal Writing Program. Any first-year student who has not received information regarding these classes or who has questions, should contact the Legal Writing Program. During training sessions, other students are asked to use the Westlaw terminals on the first floor of the library.

### **LIBRARY STUDY HALL**

Beginning **Monday, November 18** the library will remain open extra "study hall" hours. Regular closing time will be extended until 2 a.m. Also, the library will open at 9 a.m. on weekdays.

During these hours there will be no librarians on duty, but the library will be patrolled by security guards. All the reserve rooms will be closed. All circulation transactions, including borrowing and returning books and the charge-in and charge-out of reserve materials must be completed during the normal library hours.

The extended hours will remain in effect through the end of finals, except they will be suspended for the Thanksgiving recess: **November 27** through **December 1**. For Thanksgiving hours, consult the schedules posted in the library.

Study hall is for NYLS students only. Students should remember to bring their NYLS ID cards, as the guards will check for them at closing time.



## **FINANCIAL AID**



### **PUERTO RICAN LEGAL DEFENSE AND EDUCATION FUND SCHOLARSHIP PROGRAM FOR LAW STUDENTS**

The Puerto Rican Legal Defense and Education Fund was funded in 1972 to struggle for social change and equality for Latinos. The Education Division works to ensure that students of color have full and equal access to the legal profession. Through a variety of programs including personal counseling, writing workshops, mentorship, LSAT-preparatory courses, scholarships and internships, the Division continues to assist a new generation of quality public interest attorneys serving the Latino community.

PRLDEF has for many years enlisted the assistance of foundations and individuals to provide economic support to students who demonstrate a need for additional resources to finance their legal education. PRLDEF administers two separate grants. In addition, PRLDEF submits applicants to the annual national scholarship program of the Puerto Rican Bar Association located in New York City.

The Puerto Rican Legal Defense and Education Fund (PRLDEF) is pleased to announce its 1996/97 Scholarship program.

#### **PRLDEF Public Interest Scholarship Award (\$4,000 - \$5,000)**

All students attending law school in the New York City metropolitan area are eligible to apply for the Public Interest Scholarship Award. The most important criteria is a demonstrated commitment to public interest law.

#### **Father Joseph P. Fitzpatrick Scholarship Fund (\$1,000 - \$2,000)**

All Latino students attending law school in the United States are eligible to apply. Students must demonstrate financial need as well as a commitment to the Latino community.

#### **Puerto Rican Bar Association (PRBA) Scholarship Award (\$1,000)**

All Latino students attending law school in the United States are eligible to apply. PRBA selects recipients based on financial need and academic promise.

Applicants to all scholarships must be candidates for a J.D. degree at an American Bar Association (ABA) approved law school. Students working towards their LL.M. are not eligible for these awards.

#### **APPLICATION DEADLINE:**

All scholarship applicants must submit a complete and accurate application and required supplemental materials postmarked or hand delivered on or before Friday, January 31, 1997 by 5 pm. No extensions will be granted; no exceptions.

Scholarships recipients will be announced in JUNE, 1997. PRLDEF will make the awards at a reception to be held in September 1997.

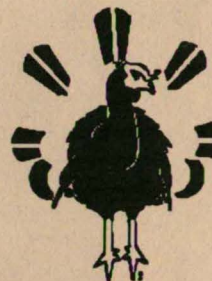
### STUDENT ORGANIZATION EVENTS
