## LLOYD'S OF LONDON SYMPOSIUM

New York Law School's Center for International Law will present a symposium, titled "Implications of the Reconstruction of Lloyd's of London," on **Wednesday, November 6**, from 2 to 5 p.m. in the Ernst Stiefel Reading Room. It will analyze the reconstruction of Lloyd's and the future of this and other major insurance markets. The symposium is co-sponsored by the *NYLS Journal of International and Comparative Law*.

The four speakers are Edward J. Muhl, Superintendent of Insurance, New York State Insurance Department; Nicholas E.T. Prettejohn, Head of Strategy, Lloyd's of London; Sean F. Mooney, Senior Vice President and Economist, Insurance Information Institute, Inc.; and Christian M. Milton, Vice President, Reinsurance, American International Group, Inc. Following their presentations they will answer questions from the audience. The event will be hosted by Sydney M. Cone, III, C.V. Starr Professor of the Law of International Trade and Finance and Director of the NYLS Center for International Law.

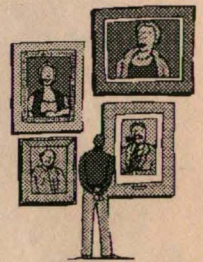

PUBLIC INTEREST (LSPIN)  
FELLOWSHIP PROGRAM**

This program will provide summer grants for first and second-year law students to work with public interest organizations in the New York metropolitan area. It is designed to give qualified and committed law students the opportunity to explore career opportunities in public interest law and public service. Approximately forty-two grants of \$3,250 will be awarded to students attending law school in New York and New Jersey for ten weeks of full-time work during the summer of 1997. The application DEADLINE is December 3.

**PUBLIC INTEREST LAW INITIATIVE  
(PILI) - SUMMER INTERNSHIP PROGRAM**

PILI recruits law students nationwide, funds positions which would otherwise not exist, ensures quality supervision by the legal staff at the participating agencies and provides an educational structure for interns. The educational program includes regularly scheduled seminars on a range of public interest law issues. It is the hope of the founders and directors of PILI that this opportunity will reinforce a life-long participation in public interest law. Applications are available.

**PUERTO RICAN LEGAL DEFENSE  
AND EDUCATION FUND  
(PRLDEF) SCHOLARSHIPS**

PRLDEF provides two distinct scholarship programs: the Joseph P. Fitzpatrick National Scholarship and the Public Interest Scholarship. The annual National Scholarship provides five \$1,000 awards to Puerto Rican and other Latino students who are presently enrolled in law school or have been accepted into law school. The awards are based upon the student's submission of an application, academic promise, involvement in the Latino community and financial need. The Public Interest Scholarship provides \$4,000 - \$5,000 awards to law students, regardless of ethnicity, who attend law school in the New York and New Jersey metropolitan area. Students are selected based upon submission of an application, financial need and a strong, demonstrated commitment to public interest or community service work.
