#### LEGAL AID SOCIETY FELLOWSHIP AWARDED



Congratulations to Arnold Levine '93 who is this year's recipient of the New York Law School - Legal Aid Society Fellowship. He will begin his work in the Criminal

Defense Division this semester and will work for the Legal Aid Society for the next three years.

#### FACULTY ACTIVITIES

Professor Stephen Elimann was selected earlier this month to serve as one of the three co-editors-in-chief of a new journal of clinical legal scholarship. He spoke at Fordham Law School on January 21, 1993, addressing issues from his recent article on the representation of groups, as part of a class on "Lawyering Empowerment." In late November 1992, he traveled to South Africa to study and discuss issues surrounding constitutional negotiations. While there, he spoke at a faculty seminar at the University of the Witwatersrand on discrimination by private as opposed to state actors in American constitutional law and in South African constitutional proposals; he also met with the African National Congress' Constitutional Committee to talk about pending constitutional questions. In November, he also spoke on South African constitutional issues to a class at Rutgers Law School, and discussed the control of internal security powers in a future South Africa at a Legal Issues Workshop during the National Conference in Support of the A.N.C. and Other Democratic Forces for a New South Africa.

**Professor Keri Gould**'s article, "Therapeutic Jurisprudence and the Arraignment Process (The Defense Attorney's Dilemma: Whether to Request a Competency Examination)" will be published in the spring Special Issue of the International Journal of Law & Psychiatry.

**Professor Karen Gross was recently appointed** to the American Arbitration Association's National Advisory Committee for Bankruptcy ADR. The committee, composed of Bankrupcty Judges, practitioners and experts on mediation, will address issues arising from the increasing number of cases and growing criticism of the bankruptcy process.

**Professor Arthur Leonard's** letter on gays in the military was published in the New York Times on December 2, 1992. His letter on age of consent laws was published in The Responsive Community (Winter 1992/93, Vol. 3, No. 1).

On January 6th and 14th, Professor Nadine Strossen did hour-long interviews on WNIS News Radio, based in Norfolk, VA. On January 25, she will deliver a lecture at the University of North Carolina Law School to commemorate the twentieth anniversary of Roe v. Wade. On January 27-30th, she will represent the United States at a gathering of 50 human rights activists from around the world, convened by the Council of Europe, in Strasbourg, France. On January 31st, she will participate in a panel at the 92nd Street Y in New York on "Is Sex Politically Correct?" Other panelists include writers Erica Jong, Gay Talese, Nicholson Baker, Christopher Cerf, and Andrea Dworkin. For tickets, call the 92nd Street Y at 996-1100.
