On April 30, she was interviewed on NBC-TV's "Nightside" program, debating the proposed flag desecration amendment to the Constitution with General Patrick Brady, Chair of the Citizens' Flag Alliance. Professor Strossen will be a guest on "The Late, Late Show" with Tom Snyder, on CBS-TV, on May 22.

It is part of OCLC, an online cataloging utility which maintains the largest bibliographic database in the world, containing almost 40 million records representing the collections of over 22,000 libraries throughout the United States and the world.
