BARBARA ARONSTEIN BLACK NAMED N.Y.L.S. TRUSTEE

On October 13th, Barbara Aronstein Black was elected to The New York Law School Board of Trustees. Ms. Black holds degrees from Columbia University School of Law and Yale University. A Professor of Law at Columbia since 1984, Ms. Black was Dean of the Faculty of Law from 1986 to 1991.

While the team coached by Michael Cifelli did not advance past the first round, team members Brian Schwartz and James Mendel were praised by judges and other competitors for their performance.

CIVIL LAW CLINIC FILES CHALLENGE V. THE BANK OF NEW YORK



The Civil Law Clinic was successful in a challenge it filed on behalf of East Harlem Interfaith against The Bank of New York's application to the Federal Reserve Board to purchase Barclays Bank's

New York branches. The Clinic, including Professors Carol Buckler, Lawrence Grosberg and Richard Marsico, and students Steve Krasner and Andrew Pappas, argued that BONY had inappropriately excluded the predominantly minority/low income areas in Manhattan north of 96th Street and in the Bronx from its lending area in violation of the Community Reinvestment Act. As a result of the challenge, the Federal Reserve Board persuaded BONY to voluntarily include these communities in its lending area. The Board took an unusual further step by approving the application on the condition that BONY comply with its

commitment to meet the credit needs of these areas and submit written reports on its progress.

FACULTY NEWS

At Capital University Law School's November 11th symposium, "Confrontation after *Illinois v. White*," Professor Randolph Jonakait commented on the right to confrontation and the Federal Sentencing Guidelines.

Professor Arthur Leonard's article entitled "Legal Constraints on Employment Screening for Sexual Orientation" was published in the October 1992 issue of Employment Testing Law & Policy Reporter.

Professor Nadine Strossen lectured on November 4th at Penn State University on the prospective climate for civil liberties under the Clinton Administration. On November 22nd, she gave a talk at the North County Council of Social Agencies in Watertown, N.Y. on the Supreme Court and civil liberties. In November, Professor Strossen also participated in the Anti-Defamation League and the Humanities Foundation's panel discussion, "Anti-Semitism: Where Does It Fit In?" broadcast on public television. On CNN's "Crossfire," Prof. Strossen debated The Reverend Jerry Falwell on "The Social Agenda of the Clinton Administration." Prof. Strossen was also a panelist on the PBS broadcast, "Rage, Rap, and Rock," a discussion of free speech in entertainment media moderated by Harvard Law Professor Charles Ogletree.


NEWS OF NOTE
