

#### N.Y.L.S. WINS REGIONAL ROUND OF NATIONAL MOOT COURT COMPETITION

The New York Law School defeated Cornell, New York University, Cardozo, Seton Hall, and Brooklyn Law School to win the National Regional Round of the 43rd Annual National Moot Court Competition held on November 18-19th in New York. The National Competition, sponsored by the Young Lawyers Committee of the Association of the Bar of the City of New York, is regarded as the nation's most prestigious moot court competition. The team, consisting of students Ann Kenny and Bryce Moses. coach Arnold Levine, and faculty advisor, Prof. Gerald Lebovits were undefeated in five rounds beating Brooklyn Law in the finals. The New York Law School was awarded permanent possession of the Whitney North Seymour Bowl and will receive law books donated by regional sponsors. In January, the N.Y.L.S. team will compete in the National Rounds.

## '92 GRADUATE EARNS PRIZE IN ASCAP COMPETITION

Robert J. Leonard '92 won second prize in the American Society of Composers, Authors and Publishers' Nathan Burkan Memorial Competition for his essay, Combatting International Copyright Piracy: A World Community Policy Approach. ASCAP's awards, established in 1938, were created to promote scholarship in the field of copyright law. Mr. Leonard's work will also be considered for one of five National Prizes.

#### ABA NEGOTIATION COMPETITION

Two teams from The New York Law School participated in the Regional Finals of the ABA Negotiation Competition at Seton Hall School of Law on November 14th. Out of twenty-four teams, Eric Gottfried and Donna Thompson finished fourth and Susan-Allison Schumer and Eric Coles placed eighth.

#### **FACULTY NEWS**

Professor Karen Gross lectured at the University of Wisconsin on November 2nd on her research on early women debtors. Prof. Gross was also panelist at the N.Y.L.S. Alumni Association's P.L.E.A. (Practical Legal Education for Attorneys) program, Bankruptcy: The Basics, on November 19th.

Professor William LaPiana was elected a Fellow of the American College of Trust and Estate Counsel, an international association of distinguished trust and estate practitioners, at a recent meeting of its Board of Regents in Seattle, Washington. The College actively pursues improvement of the tax and judicial systems and provides scholarly publications and programs of continuing legal education to its Fellows.

Professor Richard Marsico participated in a panel discussion about the relationship between law school clinics and legal services offices at a meeting of the National Legal Aid and Defenders Association in Toronto on November 13th.

Professor Carlin Meyer was a panelist at the symposium, Decriminalizing Prostitution: Liberation or Dehumanization? sponsored by Cardozo School of Law on November 17th.

Professor Michael Perlin presented the paper, Homelessness and Mentally Ill Persons: Sanist Myths and Social Realities at a conference sponsored by the University of Pennsylvania Medical School in October. Earlier this month, Prof. Perlin presented the paper, The Americans With Disabilities Act and Mentally Disabled Persons: Can Sanist Attitudes Be Undone?" at Hofstra Law School. At Kirby Forensic Psychiatric Clinic, Prof. Perlin gave the Grand Rounds presentation, Hospitalized Patients and the Right to Sexual Interaction: Beyond the Last Frontier?"

Professor Nadine Strossen debated Daryl Gates, former Chief of the Los Angeles Police Department, at the University of Pittsburgh on November 11th and at the University of Michigan at Ann Arbor on November 19th. She delivered the keynote address, "Women and Civil Liberties" at a Conference of the Radcliffe Alumnae Association on November 13th. The Women's League for Conservative Judaism, an international organization. awarded its Woman of Distinction Award to Prof. Strossen at a conference on November 17th. On November 22nd, she was interviewed on CBS Morning News about changes on the Supreme Court in the Clinton Administration. At the University of North Carolina at Chapel Hill, Prof. Strossen debated Ed Meese on the topic, "Is the Justice System Fair?" on November 23rd. Prof. Strossen was also profiled in the December issue of **VOGUE Magazine**.
