CITYLAW BREAKFAST FEATURES CUNY CHANCELLOR MATTHEW GOLDSTEIN

The New York Law School Center for New York City Law Breakfast Series will feature City University of New York Chancellor Matthew Goldstein on Fri., Feb. 23, 8:15-9:30 am, Ernst Stiefel Reading Room.

Dr. Goldstein was appointed chancellor of CUNY on Sept. 1, 1999. He is the first CUNY graduate to lead the nation's most prominent urban public university.

He has served in senior academic and administrative positions for more than 20 years. Prior to being named chancellor, Dr. Goldstein was president of Adelphi University. He has also served as president of Baruch College, president of the Research Foundation, and acting vice chancellor for academic affairs at CUNY.

Dr. Goldstein was recently appointed to Gov. George E. Pataki's Advisory Committee for the Rivers Institute, Senator Charles Schumer's Group of 35 Blue-Ribbon Task Force on NYC Commercial Space and the NYS Education Commissioner's Advisory Council on Higher Education. He was a member of the Research and Development Subcommittee for the Governor's Conference Committee on Science and Technology, and on Governor-elect Pataki's Higher Education Transition Task Force.

He earned his doctorate in mathematical statistics from the University of Connecticut, and a bachelor's degree in statistics and mathematics from the City College, CUNY.

Some of the sites include US embassies and consulates (listing of foreign embassies such as US Embassy in Montevideo, www.embeeuu.gub.uy); US Department of Labor, www.dol.gov; The Federal Judiciary Homepage, www.uscourts.gov; US Court of Appeals for the Federal Circuit, www.fedcir.gov; USPTO Patent Databases, http://patents.uspto.gov.

☐ The Green Book: The Official Directory of the City of New York - This book provides a comprehensive listing of government agencies city-wide and includes agency names, addresses, and phone and fax numbers. The publication also contains information on international organizations and foreign consulates housed in NYC. This resource also can be accessed on the web at www.ci.nyc.ny.us (To access services and government agencies, at the right of the web page, click 'go' for agency list).

Legal Careers in New York State Government - This directory was designed to assist law students and lawyers considering government careers with the State of New York. Part I of the directory discusses employment opportunities NY State Government, along with a detailed description of the ways to secure such employment including the civil service examina-

tion. Part II focuses on employment opportunities with the NY State Legislature. Part III covers jobs with NY State Municipal Governments and other government offices.
