# CITYLAW BREAKFAST SERIES FEATURES RANDI WEINGARTEN, UFT PRESIDENT

The New York Law School Center for New York CityLaw Breakfast Series will feature Randi Weingarten, president of the United Federation of Teachers, on Fri., Dec. 1, 8:15-9:30 am, Ernst Stiefel Reading Room.

As president of the United Federation of Teachers (UFT), Ms. Weingarten represents over 130,000 active and retired non-supervisory educators in NYC public schools. In one of the sharpest disputes currently dominating local news headlines, she is in the midst of attempting to negotiate a new teachers' contract with Mayor Giuliani. Ms. Weingarten also serves as a vice-president of the national American Federation of Teachers and is a board member of the NYC Central Labor Council.

Prior to assuming UFT's helm in February of 1998, she served for 12 years as Counsel to the UFT President, spear-heading the union's legal efforts to achieve smaller class sizes and to require improved school maintenance by the City.

From 1991 to 1997, while holding down her union posts, Ms. Weingarten taught social studies and history full- and part-time at Clara Barton High School in Brooklyn.

Prior to her union and teaching career, she served as a legislative assistant to the State Senate Labor Committee, as a member of the Board and Chairman of the Health Insurance Plan (HIP) of Greater New York, and as an associate at the Stroock, Stroock, and Lavan law firm, where she represented the UFT and other clients.

She is an honors graduate of Benjamin Cardozo Law School and holds a BS degree from Cornell University.

Ms. Weingarten belongs to the New York State and City Bar Associations.
