WAGNER COMPETITION RESULTS

Teams of students from 44 law schools competed in the 25th Annual Robert F. Wagner Sr. National Labor and Employment Law Moot Court Competition, which took place at the School, March 8-March 11. Presented by the New York Law School Moot Court Association, the Wagner is the largest student-run moot court competition in the country.

This year's case centered on sexual discrimination and retaliation claims in the workplace. Final rounds were argued before a distinguished panel of judges, which included Richard Matasar, dean; Prof. Nadine Strossen, president of the national American Civil Liberties Union; the Hon. John Truesdale, National Labor Relations Board chair; the Hon. Ida Castro, Equal Employment Opportunity Commission chair; and the Hon. Henry Solano, solicitor of the US Department of Labor.

The teams competed in a series of rounds over the four-day period, culminating in a final debate on March 11 between finalists Stetson University School of Law and Southern Methodist University School of Law. The Stetson group emerged as Best Team and Luis G. Zambrano of Southern Methodist was chosen Best Oral Advocate. Other winners included University of California Hastings College of the Law for Best Petitioner Brief and Seton Hall University Law School for Best Respondent Brief.

The judges were highly impressed with this year's contenders. In choosing the final winners, Wagner Chief Justice Castro confided that "it was extremely, extremely difficult for us. You are all winners!"

"A Lawyer has an Obligation: Pro Bono and the Legal Profession will be discussed during the 2001 Otto L. Walter Lecture on Tues., April 10, 4:30-6 pm, Wellington Center.

Evan A. Davis, president of the Association of the Bar of the City of New York, will speak about lawyers' ethical responsibility to provide pro bono services. He will examine what the legal profession can do to support and expand pro bono opportunities; and what the future holds for lawyers and students interested in public interest law. Mr. Davis is a partner at Cleary, Gottlieb, Steen & Hamilton.

Pro bono work remains one of a lawyer's greatest obligations to society. But as the legal profession has become more stressful in recent years, some lawyers are committing less time and fewer resources to pro bono work. And, as public funding for legal aid programs remains inadequate, there is reason for concern that the need for pro bono assistance will not be met.

C.V. Starr Professor of Law Sydney M. Cone, III, director of the Center for International Law, will host the lecture.

FACULTY AND ADMINISTRATIVE ACTIVITIES

PROFESSOR KAREN GROSS was a panelist on "Women and Debt: The Impact of Insolvency on Women and Families" at the World Women Lawyers Conference in London, England held in March.

PROFESSOR SETH HARRIS' article "Conceptions of Fairness and the Fair Labor Standards Act" appeared in the recent issue of the Hofstra Labor and Employment Law Journal. The article examines the history of the debate over fairness in wages.

PROFESSOR RICHARD MARSICO was a presenter at the annual conference of the National Community Reinvestment Coalition on March 5. He critiqued the federal banking regulatory agencies' application of the Community Reinvestment Act regulations to the home mortgage lending record of large banks

DEAN RICHARD A. MATASAR was interviewed for a March New York Lawyer magazine article on "Thinking of Clerking Your Way to the Top?", addressing the realities and rewards of clerkships.

PROFESSOR DENISE MORGAN spoke about the Campaign for Fiscal Equity litigation on the Education Workshop Panel at the New York State Association of Black and Puerto Rican Legislators Conference weekend in February.

PROFESSOR MICHAEL PERLIN's article "Stepping Outside the Box: Viewing Your Client in a Whole New Light" was published as part of a creative problem solving symposium which appeared in 37 Cal. West. L. Rev. 65 (2000).

He was quoted in the Feb. 9 issue of the New York Law Journal regarding Amianna (Patel) Stovall, a former student/ballerina, and in the Feb. 5 Richmond Times-Dispatch on the use of the insanity defense in cases of serious felonies.

PROFESSOR EDWARD PURCELL has won the Griswold Prize for his book Brandeis and the Progressive Constitution: Erie, the Judicial Power, and Politics of the Federal Courts in Twentieth Century America (Yale University Press, 2000). The award is given by the Supreme Court Historical Society once every three years. He will lecture in the Supreme Court Chambers on May 23.

PROFESSOR EDWARD SAMUELS' book review of Michael White's Acid Tongues and Tranquil Dreamers: Tales of Bitter Rivalry That Fueled the Advancement of Science and Technology, was published in the April 2001 issue of Wired magazine. It will appear on the Wired Web site beginning next month.

PROFESSORS DAVID SCHOENBROD AND

ROSS SANDLER have published an article on the New York City school financing case, "After the Court's Ruling-What Next for the Schools?", which appears in 7 City Law 1 (2001).

Prof. Schoenbrod and Marci Hamilton, a professor of law at Cardozo Law School, have written an op-ed, "Congressional. Review Act Gives Lawmakers a Much-Needed Power", which was published in the March 11 issue of the Philadelphia Inquirer.

Prof. Schoenbrod was quoted in the March 5 issue of Legal

Times and in a March 4 Boston Herald editorial on the

American Trucking Association v. Browner case. The Legal Times
also quoted him on the Congressional Review Act in its March
12 issue.

ASSOCIATE DIRECTOR OF CAREER SERVICES ADJUA STARKS moderated a panel discussion at the annual New York University Public Interest and Public Service Symposium in February. The "Careers in Criminal Law" panel included Michael Judge, the chief public defender from the Los Angeles Public Defender's Office.

PROFESSOR NADINE STROSSEN has spoken on a range of constitutional law issues at various campuses, including: the Distinguished Speaker Lecture at Duke Law School in Durham, NC; Keynote Lecture, Annual Winter Forum, Emory and Henry College, Emory, VA; the Public Interest Law Summit hosted by the Center for Public Interest Law, University of San Diego School of Law; a forum sponsored by the Annual Survey of American Law, New York University School of Law; debated former US Attorney General Edwin Meese on "Pornography and Censorship," University of Tennessee, Knoxville, TN; and Annual Distinguished Speaker Program, Albion College, Albion, MI.

Prof. Strossen also has discussed constitutional and civil liberties issues on TV programs, including: ABC-TV's "Nightline," on the Child Pornography Prevention Act; PBS-TV's "Debates, Debates" ("Should the Government Give Money to Churches for Social Services?" and "Should Religion be Taught in Public Schools After School?"); ABC-TV's "Politically Incorrect with Bill Maher"; and Fox News TV's "Hannity & Colmes," discussing the death penalty for mentally retarded individuals and the issue of prosecuting children as adults. Prof. Strossen also has addressed a range of groups, including: the Atlanta Executive Network (the largest lesbian/gay business organization in the US), Atlanta, GA; the International Expert Network on "Self Regulation of Internet Content" in Singapore; and the Annual First Amendment Forum, Association of Women in Communications, Purchase, NY.

PROFESSOR RUTI TEITEL's article, "The Constitutional Canon: The Challenge Posed by a Transitional Constitutionalism," appeared in Vol.17 (2000) of Constitutional Commentary as part of a symposium on the canons of constitutional law.

In a March 4 New York Review of Books article, "Bringing Monsters to Justice," author Aryeh Neier refers to Prof. Teitel's book, Transitional Justice (Oxford University Press, 2000), as "a valuable contribution to the growing body of scholarly literature."
