## FACULTY NEWS

Professor Michael Botein's article, "Cable Regulation Bill: Boon to Broadcasters or Viewers?" appeared in the Outside Counsel column in the New York Law Journal on September 23.

Professor Karen Gross will be speaking in San Antonio for the American Bar Association Business Bankruptcy Meeting which is held in conjunction with the National Bankruptcy Judges Conference. Her topic is "The Future of Chapter 11." She is using a portion of a draft chapter of her forthcoming book, tentatively titled Breaking Benches: An Assessment of Contemporary Bankruptcy Law as written materials for the presentation. The chapter is on the need to take community interests into account in reorganization cases and critiques the narrow perspective people currently have on bankruptcy law.

Professor Michael L. Perlin's article, Psychodynamics and the Insanity Defense: "Ordinary Common Sense" and Heuristic Reasoning, originally published in the Nebraska Law Review, has been reprinted in Law and Psychology: The Broadening of the Discipline edited by Professor James Ogloff and published by the Carolina Academic Press. An excerpt from his article, Power Imbalances in Therapeutic and Forensic Relationships, originally published in Behavioral Science and Law, is being reprinted in The Psychiatric Times. His article, Sanism, Social Science and the Development of Mental Disability Law Jurisprudence (co-authored with Deborah A. Dorfman, NYLS '92), has been accepted for publication in a Jurisprudence symposium in Behavioral Sciences and Law. A short paper that he presented this past June at the International Congress of Law and Mental Health (Therapeutic Jurisprudence: A Multi-Professional Perspective) will be published in a Book of Proceedings of a selected conference papers by Simon Fraser University Press (Vancouver). A paper he will be presenting this month at the American Academy of

Psychiatry and Law's annual conference (**Riggins v. Nevada: Forced Medication Collides With the Right to a Fair Trial**) will be published in the Newsletter of the American Academy of Psychiatry and Law. He will be giving a second presentation at that conference on AIDS and the Criminal Law: The Jackson v. Indiana Dilemma and Beyond. Professor Perlin was also interviewed by Newsday last week on empirical and social myths about the insanity defense.

Professor Nadine Strossen participated in a Fordham University School of Law panel on "Constitutional Issues in the 1992 Presidential Campaign" on October 1.

Professor Ruti Teitel is a recipient of a grant from the United States Institute of Peace to study questions of justice during regime changes. Her article, "Dilemmas of Justice" came out in the fall issue of the University of Chicago Law School East European Constitutional Review. She lectured on September 10 at a conference on Developments in Church/State law, American Jewish Committee, on "The Collapse of the Religion Clauses."
