NYLS-LEGAL AID SOCIETY FELLOWSHIPS

FACULTY NEWS

Professor Michael Botein's article "U.S. Telecommunications in the World Market: Changing Policy Considerations" appeared in the New York Law Journal on September 3.

Professor Karen Gross has agreed to serve on the Advisory Board of a new law review that is being sponsored by the American Bankruptcy Institute and which will be housed at St. John's Law School. The inaugural issue will be thematic and will address single asset real estate cases. She served as a National Advisor to the Bankruptcy Task Force of the Ninth Circuit Gender Bias Task Force. The Ninth Circuit Task Force recently issued a 181 page report on its findings, and Professor Gross' piece "A Re-Vision of the Bankruptcy System: New Images of Individual Debtors" was cited. During the summer, Bankruptcy Court Decisions did a profile on her scholarship with particular attention to her work on women in debt. Professor Gross was also recently interviewed by the Associated Press on bankruptcy filing rates and the Cleveland Plain Dealer on Judge Lifland and judicial activism in bankruptcy cases.

Professor Nadine Strossen lectured at the University of Kansas on "Hate Crimes and Codes of Conduct" and at the University of Kansas Law School on recent Supreme Court decisions on September 2. She spoke at a conference on Developments in Church/State law, American Jewish Committee, on "The Rehnquist Court's Statist Agenda" on September 10.
