The program focuses on a plan by PTT-Telecom of the Netherlands to provide itemized phone bills to its customers, an accepted practice in the U.S., which has alarmed journalists and people in the legal and medical professions concerned that sources, clients and others will no longer feel secure when using the telephone.

FACULTY NEWS

Professor Stephen Ellmann has recently published three articles, two on issues of lawyering technique and legal ethics and the third on developments in South Africa. The articles are: Client-Centeredness Multiplied: Individual Autonomy and Collective Mobilization in Public Interest Lawyers' Representation of Groups, 78 Va. L. Rev. 1103 (1992); Empathy and Approval, 43 Hastings L.J.

991 (1992); and Visions of Legitimation in Old and New South Africa: A Summary and Response, 16 Legal Studies Forum 193 (1992).

Congratulations to Aleta Estreicher, who was promoted to full professor and granted tenure at a recent Board of Trustees meeting. Professor Estreicher, who has taught classes in Corporations, Property Law, Corporate and Securities Law and Security Regulation, has been a member of The New York Law School faculty since 1984.

Professor Arthur Leonard will be in Victoria, British Columbia, Canada from October 18-22 as the Landsdowne Visitor at the University of Victoria Law School. He will deliver the annual Landsdowne Lecture (Topic: Making Rational AIDS Policies) and conduct a faculty seminar on recognition of non-traditional families, in addition to meeting with local AIDS policy and service groups and delivering a talk on recent legal developments in lesbian and gay rights in the U.S. to the University's Lesbian/Gay/Bisexual Alliance. On October 23-25, Professor Leonard will participate in the Lavender Law III conference in Chicago, presented by the National Lesbian and Gay Law Association. He moderated and participated in a panel discussion on HIV-related discrimination and new directions in lesbian and gay legal scholarship. He presented a seminar at the Human Rights Watch office in New York on legal protection for the civil and human rights of U.S. workers on October 13. On October 15, he participated as a member of a special advisory committee to the ACLU Task Force on Civil Liberties in the Workplace in discussing the appropriate position for the ACLU to take on the Electomation decision by the National Labor Relations Board, which concerns whether it violates federal labor law for an employer to establish worker committees to study workplace grievances and present proposals for changes in working conditions to management.

Professor Nadine Strossen will participate in a panel sponsored by the Federalist Society of New York Lawyers' Division on "Is the Supreme Court Really Conservative?" at the New York Helmsley on Wednesday, October 21 at 6:30 p.m. For more information, contact (718) 855-1113. On October 27, she will debate Edwin Meese on "Controversies Surrounding the Bill of Rights" at McGinley Center, Fordham Univ. in the Bronx at 2:00 p.m. A reception will follow. For more information, contact Ms. Nevie Repetti, Fordham Student Activities, at (718) 579-2339. Throughout the month of September, Professor Strossen lectured at several colleges and universities. On September 9th, she addressed the National Council of Jewish Women on "Our Endangered Civil Liberties," and gave a presentation at the Conference on Developments in Church/State Law, sponsored by the American Jewish Committee, in New York City on "Is the Criminal Justice System Racially Discriminatory?" Professor Strossen testified before the U.S. Senate Judiciary Committee in Washington, D.C., in support of the Religious Freedom Restoration Act. On the 30th, she was interviewed for "Mornings with Bryan and Bob," WRC Radio, Washington, D.C., on a critique of the Pornography Victims Compensation Act.
