#### PROFESSOR WILLIAM LaPIANA GRANTED TENURE

William P. LaPiana, an Associate Professor of Law at N.Y.L.S. since 1987, was promoted to full professor with tenure last week. Prof. LaPiana joined The New York Law School after four years as an assistant professor at the University of Pittsburgh School of Law. Previously, he was an associate of the New York City firm of Davis Polk & Wardwell. At N.Y.L.S., Prof. LaPiana teaches Wills, Trusts and Future Interests, Taxation of Estates and Gifts, American Legal History, Property, and Estate Planning.

#### FACULTY NEWS

**Professor Richard Beck** published the article "The Innocent Spouse Rules" in the Fall 1992 issue of the *The Family Advocate*, an edition focusing on tax and divorce issues.

**Professor Keri Gould** was co-chair of the November 6th Hofstra Law School Conference, "The Americans with Disabilities Act: The Key to Change." She presented the paper, "Innovative Applications for the Americans with Disabilities Act." **Professor Jethro K. Lieberman** published *The Evolving Constitution: How the Supreme Court Has Ruled on Issues from Abortion to Zoning*, a work that covers approximately one thousand topics in constitutional law in encyclopedic format complete through the Supreme Court's 1991-1992 term.

**Professor Michael L. Perlin** presented the paper,"The Supreme Court and Mental Disability: New Directions for the Next Century?" at a December 11th conference sponsored by the Missouri Protection and Advocacy System. **Professor Nadine Strossen** and Ed Meese debated the topic "Justice in America: Is the System Racist?" at Northwest Missouri State College on December 1st. On December 4th and 6th, Prof. Strossen was featured on

PBS' civil liberties retrospective programs dedicated to Fred Friendly. She was interviewed on WABC radio on December 9th about censorship of rock music in Germany and the U.S. In addition, Prof. Strossen was profiled in the December 1992 issue of *The Reporter*, a publication of Women's American ORT. In November, *USA Today* quoted Prof. Strossen on civil liberties issues in the Clinton Administration.
