#### CITYLAW CONCLUDES SERIES FOR THIS YEAR

Throughout the academic year, the Center for New York City Law has hosted provocative talks from some of New York's most renown government officials and business executives.

Concluding this year's City Law Breakfast Series will be Eugene R. McGrath, president and CEO of Consolidated Edison, Inc. on Fri., April 20, 8:15-9:30 am, Ernst Stiefel Room.

Mr. McGrath joined Con Edison of New York as an engineer following college graduation in 1963. He eventually held key executive positions in the utility's major operating and customer service areas and managed fossil-fired and nuclear generating plants. He was elected vice president in 1978, executive vice president in 1982, and president and chief operating officer in 1989. He became chairman and CEO in September 1990.

Con Edison is among the largest investor-owned energy companies in the US, with revenues of more than \$7 billion. Its service areas contain nearly nine million people, almost half the population of New York State.

The deadline for submitting 2001-2002 financial aid application materials for summer federal work-study and academic year grant-in-aid is today, April 16. We suggest, however, that all applicants comply with the April 16 deadline to ensure that financial aid funds for fall 2001 can be disbursed by the start of the school year. This might include an article you have written, a statement detailing an activity in which you had significant involvement, or a letter(s), attesting to your contribution to furthering professional responsibility and/or legal ethics. (An examination answer does not qualify as a basis for the award).

Prizes: \$750; and the possibility of publication for an article (if that is the basis of the award).
