The Center for New York City Law Breakfast Series will bring many prominent New Yorkers to NYLS to speak on topics pertaining to government and politics this academic year. The series opens with Bernard H. Mendik '58, member of the NYLS Board of Trustees, discussing "Reminiscences, Real Estate and New York Law School," Fri., Sept. 17, 8:15-9 am, Ernst Stiefel Reading Room.

Mr. Mendik, the former chairman of the Mendik Company, was involved as a principle on more than 30 acquisitions of major office and residential properties in the New York etropolitan area. He is involved with many philanthropic and civic organizations. A member of the New York Bar, he holds honorary Doctor of Law degrees from NYLS and City College of CUNY. Mr. Mendik received the City of New York's Fiorello H. La Guardia Award for civic achievement in 1996.

Other 1999-2000 breakfast series speakers include: Richard D. Parsons, president, Time Warner Inc.; Benno C. Schmidt, Jr., chairman, The Edison Project; Samuel I. The Judicial Externship Program is an academic program enabling students (judicial externs) to earn law school credits by working with a judge as a volunteer and completing related assignments at the law school. This program places students with state and federal judges and federal magistrates in NYC and the surrounding jurisdictions.

FACULTY ACTIVITIES

PROFESSOR KAREN GROSS spoke at the Northeast Bankruptcy Conference sponsored by the American Bankruptcy Institute and participated in the consumer forum addressing the proposed legislation and reaffirmation agreements in July. On Sept 14, she will give a community lecture on consumer bankruptcy and will sign the paperback edition of her book *Failure and Forgiveness*, at Borders bookstore in Stamford, CT.

On Sept. 22, Prof. Gross will speak to the staff at the Southern District of New York Bankruptcy Court on "The Profile of Individual Debtors: Who are They?"

She was appointed to the Consumer Committee of INSOL, the largest international insolvency organization. Additionally, Prof. Gross was named Outstanding Bankruptcy Law Professor for 1999 by Turnaround & Workouts, a major bankruptcy organization. She has also been named Godrey Distinguished Visiting Lecturer for the spring 2000 semester at the University of Maine.

PROFESSOR TIMOTHY LYTTON gave presentations on tort suits against the gun industry at conferences in Boston and Washington this summer. He also was quoted in *Dallas Morning News* on gun liability. Prof. Lytton and second-year evening students Juan Jaramillo and Alcides Casares, gave lectures and workshops and conducted research on conflict resolution at the Universidad Nacional Autonoma de Nicaragua (UNAN) as part of the NYLS-UNAN Exchange Program for the Study and Resolution of Conflict in Nicaragua.

PROFESSOR MICHAEL PERLIN's chapter, "'Big Ideas, Images, and Distorted Facts': The Insanity Defense, Genetics, and the Political World," has been published in Genetics and Criminality: The Potential Misuse of Scientific Information in Court. The chapter is an outgrowth of a keynote address he gave at a conference on genetics and the criminal law, sponsored be the Snowbird Institute and the Departments of Psychiatry and Medical Ethics at the University of Utah School of Medicine. He recently published a teacher's manual for his casebook, Mental Disability Law: Cases and Materials.

Additionally, Prof. Perlin was quoted in The New York Times on a case in which a judge set aside a jury verdict ordering the conditional release of the notorious insanity acquittee, Albert Fentress, and in the Arizona Republic on issues related to a defendant's claim of somnambulism (sleep-walking).

PROFESSOR NADINE STROSSEN appeared this summer on many TV shows to discuss a variety of constitutional law and civil liberties issues: "Politically Incorrect;" "The Today Show;" "This Morning;" 60 Minutes;" "Crossfire, 5;" "Both Sides with Jesse Jackson;" CNN's "Hannity & Colmes;" "The Crier Report;" "The O'Reilly Factor;" "Fox Files;" "The Johnnie Cochran Show;" "Snap Judgment" on Court TV; "Cross Talk;" and "POV". Her radio interviews included "Justice Talking" and "The Diane Rehm Show" on National Public Radio, and syndicated talk shows hosted by Oliver North and Sean Hannity.

Prof. Strossen delivered the commencement address at the University of Wisconsin-Madison. She also gave the keynote addresses at the annual conventions of the association of Alternative Newsweeklies, American Library Association, National Youth Leadership Forum on Politics and Law, and American Bar Association Section on Litigation. Recent lectures also took her to Mexico, Germany, New Zealand, and Australia.

PROFESSOR RICHARD SHERWIN organized one of the core "theme" panels entitled "Law in the Age of Images" for the annual Law & Society conference in May. The theme of the panel was "The Legal Imagination: Law and the Image." On August 19, his paper at UCLA's annual "Visible Evidence" conference discussed "How can truth be visually represented; or can it?" □
