FACULTY ACTIVITIES

PROFESSOR LAWRENCE GROSBERG gave a talk on clinical methodology in the large classroom, at a conference of clinical law professors in Moscow in May. When he served as the clinical legal education specialist for the ABA Central and East European Law Initiative in Russia in June, he gave workshops on clinical education for law professors teaching in several cities.

PROFESSOR JEFFREY HAAS is quoted on the pros and cons of a tracking stock equity structure in Money Magazine, October 1999.

PROFESSOR ARTHUR LEONARD participated as a panelist and moderator at an international conference on legal recognition of same-sex partners at King's College, University of London, England in July. In August, he participated as a speaker and workshop facilitator at a conference on disability employment discrimination law at the Convention Center, Madison, WI, under the auspices of a coalition of organizations including the Wisconsin State Bar.

PROFESSOR SADIQ REZA's article, "Religion and the Public Defender," was published this summer in the Fordham Urban Law Journal, which followed the Fordham University School of Law's symposium on rediscovering the role of religion in the lives of lawyers and and their clients. His article argues that public defenders cannot deviate from professional rules to the detriment of clients based on religious convictions. On Oct. 2, Prof. Reza will participate in an inaugural national conference of Muslim lawyers and law students at Northwestern University School of Law, Chicago.

PROFESSOR DAVID SCHOENBROD participated in a panel on the "American Trucking Association" case, Cato Institute, Washington, DC, in June. He served as a panelist on delegation at the American Political Science Association's annual convention in Atlanta in September. Additionally, Prof. Schoenbrod will speak at the Federalist Society's annual convention on delegation in Washington, Nov. 11 and will speak on environmental federalism at the American Highway User's annual convention in Washington on Nov. 30.

PROFESSOR NADINE STROSSEN was on Fox News' "Hannity & Colmes," debating former high school principal Joe Clark (inspiration for the movie "Lean on Me") about school vouchers and on "Foxfiles" about government-sponsored religious exercises in the public schools, in August. Prof. Strossen appeared, in September, on CNN about school safety measures that threaten students' and teachers' rights. She was on the "Newshour with Jim Lehrer," debating Clint Bolick, litigation director of the Institute for Justice, about the constitutional controversies surrounding school voucher measures. She was a featured speaker at a program in Peekskill, NY marking the 50th anniversary of "the Peekskill riots," following a concert by the controversial leftist African-American singer and human rights activist, Paul Robeson. Additionally, Prof. Strossen was on NBC-TV's Nightly News and MSNBC discussing the civil liberties dangers of the growing trend toward school's profiling students. On Sept. 10 and 11, Prof. Strossen spoke about free speech dangers of industry "self-regulation" of Internet content, at the International Internet Content Summit convened by the Bertelsmann Foundation in Munich, Germany. She was interviewed for various media including for the "Tomorrow" show on NTV (the German CNN). On Sept. 13, Prof. Strossen debated against Clint Bolick, litigation director of the Institute for Justice at Stanford Law School, on "School Vouchers: Are They Constitutional? Are They Wise?" The program was sponsored by the Federalist Society.

PROFESSOR RUTI TEITEL spoke about her forthcoming book, Transitional Justice, at the Seventh Annual Conference on the Individual vs. the State, in Budapest, Hungary, in May. She also spoke on "The Role of Law in Radical Political Change" at the American Academy in Berlin. Additionally, Prof. Teitel presented a report entitled "Possibilities for International and National Criminal Prosecution in Cases of Political Transition" at the International Colloquium on Criminal Law in Reaction to State Crime, at the Max Planck Institute for Foreign and International Criminal Law, Freiburg im Breisgau in June.
