LAW IN TRIBECA SERIES KICKS OFF SCHOOL'S NEW COMMUNITY INITIATIVES

"The Election, the Supreme Court, and You" kicks off New York Law School's Law in TriBeCa series on Tues., Oct. 24. The series of public forums is just one of the School's new community initiatives.

Cosponsored by the TriBeCa Partnership and the Center for New York City Law, the program is open to the public at no charge. The discussion will be held 5-7 pm in the Ernst Stiefel Reading room with refreshments provided by one of the city's premier restaurants, Bouley Bakery, TriBeCa.

The inaugural Law in TriBeCa panel promises to provide a no-holds-barred discussion. Leading opinion-makers and legal scholars will explore the profound impact the impending November election will exert upon the membership and decision-making of the Supreme Court.

Guest panelists Floyd Abrams, partner at Cahill Gordon & Reindel and the William J. Brennan Jr. Visiting Professor of First Amendment Issues, Columbia University Graduate School of Journalism; Professor John McGinnis, Benjamin N. Cardozo School of Law; Rep. Jerrold Nadler, (D-NY) 8th Congressional District; and Chief Counsel Jay Sekulow, American Center for Law and Justice; will be joined by NYLS Professors David Schoenbrod and Nadine Strossen, who is president of the American Civil Liberties Union.

The School is a new sustaining member of the TriBeCa Partnership which provides employment readiness training and job placement to recovering homeless individuals in NYC through community improvement projects.

In addition to programs on special legal issues, the Law School also plans to co-sponsor cultural events—musical programs, play readings, art shows, and book readings—beginning later in the 2000-01 academic year.

Pioneering Distance Learning Program begins

Juris Alliance is a new online venture founded by New York Law School with Compass Knowledge, Inc. The distance learning program will deliver legal knowledge to working professionals through the latest technologies.

"Juris Alliance is the realization of a dream that I have had for many years," said Dean Richard A. Matasar. "Compass Knowledge is the perfect partner for creating a cutting-edge distance learning legal education system. Together, Compass and New York Law School anticipate bringing in other partners to offer a full array of legal educational products geared to the most important needs of Juris Alliance students."

Prof. Michael Perlin is teaching the inaugural 16-week program which leads to a certificate in Mental Disability Law.

Twenty-five students—including mental health professionals from throughout the US and a public defender in Guam—are already participating online. In addition, many enrollees met Prof. Perlin in person at the first of two classes at NYLS.

The only ABA-approved law school offering a certificate in mental disability law in a distance learning format, NYLS will soon introduce an online employment law course designed for human resource professionals and employment lawyers.

Did you know . . .?

In the 1960 presidential election 63% of the persons eligible to vote actually voted. In contrast, only 49% of those eligible voted in the 1996 election. While the 1996 election resulted in President Clinton's victory over Bob Dole by approximately 8.5 million popular votes, the 1960 race saw President Kennedy's margin of victory over Richard Nixon by a mere 118,000 popular votes.

The 2000 presidential election is shaping up to be one of the closest races in history. Many polls have George W. Bush and Vice President Al Gore in a virtual dead heat. Third party candidates Ralph Nader and Pat Buchanan are taking away limited but crucial numbers of votes from the Democratic and Republican candidates. In this year's election every vote will count!

FACULTY AND ADMINISTRATION ACTIVITIES

PROFESSOR LENNI BENSON was quoted in the Sept. 21 issue of the San Francisco Chronicle. She discussed the start up companies in Silicon Valley using "body shops" to hire foreign high-tech workers.

PROFESSOR MICHAEL BOTEIN announced that New York Law School is an associate member of the International Council of the National Academy of Arts and Sciences (IEMMY) with Dean Matasar serving as chief delegate. The Law School served as home base for the preliminary round judging of the "2000 International Emmy Awards," airing worldwide in November.

PROFESSOR ANNETTE GORDON-REED spoke about her book *Thomas Jefferson and Sally Hemings: An American Controversy* at the first Barbara Aronstein Black Lecture for 2000-2001 in October. The series focuses on work by or about women and their many connections to law.

On October 11, she presented a paper on "Logic and Experience: Slavery, Race and Thomas Jefferson's Life in the Law," at the Porter Fortune symposium on slavery in the United States, at the University of Mississippi. The University of Mississippi Press will publish the papers next year.

On October 12, Prof. Gordon-Reed gave a speech at the Louisville public library. On October 13, she spoke at the University of Louisville's Brandeis School of Law.

Prof. Gordon Reed was interviewed for the Arts and Entertainment "Biography" of Sally Hemings. The show is scheduled to air, Oct. 26. In November, A & E's documentary on the "Founding Fathers" is set to feature her as the Jefferson expert.

Prof. Gordon-Reed also reports that this past August she and a group of academics and writers went to Sweden as part of an African American Women Speak group to discuss race and democracy in the 21st century. The group met with several officials in the Swedish government. Prof. Gordon-Reed also was profiled in a major Swedish newspaper. "Sally and Tom follow me everywhere," she said.

Also, she has written the introductory essay about Thomas Jefferson for the recently published book for young adults, *Jefferson's Children* (Random House).

PROFESSOR KAREN GROSS addressed various topics concerning bankruptcy this fall. In September, she spoke on Pebtor Education and Financial Literacy Initiatives" at the Nassau County Bar Association, bankruptcy section.

At the National Conference of Bankruptcy Judges Academic Liaison Committee in October, she discussed "Bankruptcy and Electronic Data Collection: What Information Do You

Want, Why Do You Want It, and What Are Your Going to Do With It?" At another October conference at the American Bar Association, Business Bankruptcy subcommittee on legal education, Prof. Gross discussed "Creative Ways of Using Bankruptcy Judges and Bankruptcy Practitioners in the Law School Curriculum."

Prof. Gross also spoke about the "New Data, New Experts: The Way They Can Enhance Your Courtroom" at the American Bar Association's, Business Bankruptcy subcommittee on secured creditors and data collection.

PROFESSOR LAWRENCE GROSBERG was recently appointed chair of the Committee on Legal Education and Admission to the Bar of the Association of the Bar of the City of New York.

PROFESSOR SETH HARRIS' op-ed entitled "The Pizza Hut Subsidy" appeared in the Oct. 4 issue of the Washington Post. He discussed the sub-minimum wage for so-called "tipped employees" which Speaker Hastert has proposed freezing at its current level of \$2.13 per hour.

PROFESSOR ARTHUR LEONARD appeared before the Montclair (NJ) Civil Rights Commission to give a briefing on the current law under the 14th Amendment and Title VII of the Civil Rights Act of 1964 concerning voluntary affirmative action plans by municipalities. Prof. Leonard was invited to appear before the Commission by NYLS trustee Peter Phillips '87, who is a Commission member.

Prof. Leonard was honored at the New York Law School Journal of Human Rights symposium for his work over the past 20 years as editor of the Lesbian/Gay Law Notes newsletter.

ASSOCIATE DEAN JETHRO LIEBERMAN has been interviewed in the media including The New York Times, Washington Post, Newsweek, Hartford Courant, New Haven Register and, the Yale Daily News about his recollections of his college classmate and old friend Joe Lieberman, vice presidential candidate.

DEAN RICHARD MATASAR & PROF. MICHAEL PERLIN were featured in a front-page story of the Sept. 29 issue of the NY Law Journal. The article introduced the Law School's new venture with Compass Knowledge (see p. 1) and the new distance learning course in mental health law presented by Prof. Perlin.

PROFESSOR EDWARD SAMUELS' new web site at www.nyls.edu/samuels/copyright explains and promotes his upcoming book The Illustrated Story of Copyright due to be published in December by St. Martin's Press.

PROFESSOR DAVID SCHOENBROD and Marci Hamilton, visiting professor of law at New York University have filed an amicus brief with the Supreme Court in a delegation case for the fourth time. The case, Browner v. American Trucking Assoc., concerns the EPA's new air pollution standards. Deborah Paulus '93 also is on the brief. Nine members of Prof. Schoenbrod's environmental law class will accompany him to the upcoming oral argument. Before the argument, Deborah Duseau Simpson '93, who co-authored another amicus brief in the case, will lead a discussion for NYLS students.

PROFESSOR NADINE STROSSEN was interviewed on Oct. 2, on Ollie North's syndicated radio show about pending Supreme Court cases. On Oct. 3, NYLS students accompanied her to the Supreme Court to hear oral arguments in *Indianapolis v. Edmund*. The major Fourth Amendment case was the basis for this year's Froessel Competition Fact Pattern.

On Oct. 4, Prof. Strossen was the keynote speaker at a luncheon of the ACLU of Delaware in Wilmington. She also delivered the Dean's Distinguished Scholar Lecture at Widener Law School in Wilmington. On Oct. 7, Prof. Strossen chaired and spoke on a panel entitled "Silencing Voices" at the Tenth anniversary symposium on Academic and Intellectual Freedom at the University of Michigan. The presentation was the basis for a chapter in a forthcoming book about academic freedom (University of Michigan Press). On that same day, Prof. Strossen delivered the keynote address at the annual award ceremony of the ACLU of Illinois in Chicago.

Prof. Strossen's chapter on "Speech and Privacy" appears in the recently published The Rule of Law in the Wake of Clinton.

On Oct. 11, she delivered a lecture on "Civil Liberties in the Impending Elections" at Johnson County Community College in Overland Park, Kansas. On Oct. 13, she was a panelist for a special live production of ABC-TV's "Politically Incorrect with Bill Maher," along with conservative commentator Ann Coulter, comic Gilbert Gottfried, and Guardian Angels' founder Curtis Sliwa. The program will be televised on the College Television Network. (Look for NYLS students in the audience, including during the Q&A segment!) On Oct. 16, Professor Strossen testified at an en banc hearing of the Federal Communications Commission in Washington, DC on

Children's Television Programming and Public Interest Obligations of TV Broadcast Licensees. She was on a panel that addressed "Protecting Children from Sexually Explicit or Violent Content."

PROFESSOR RUTI TEITEL attended a Sept. 6 panel for the "Anglo-American Dialogue" Conference at New York University School of Law. She was a guest panelist speaking on transitional justice as a liberal narrative at a September conference, "Cultures of Political Transition: Memory, Identity and Voice," University of London. Prof. Teitel also was a featured panelist, addressing international issues concerning gender, attire, and rule of law at the "Women, Religious Institutions and The Law: Shaping Cultural Values," DePaul University, September 15-16.

DIRECTOR OF CAREER SERVICES CYNTHIA WYATT was interviewed in a Sept. 11 Christian Science Monitor article, "Keeping Up Appearances." The article focused on the changing dress codes in in business. Ms. Wyatt wrote an article focusing on the importance of working effectively with support staff, "Success Depends on More than Your Legal Ability" which appeared in the Sept. 5 issue of the New York Law Journal.
