As part of the new "Law in TriBeCa" series, New York Law School will host a panel discussion on "The Election, the Supreme Court, and You," Tues., Oct. 24, 5-7 pm, Ernst Stiefel Reading room.

The first in the series of forums open to the community, this panel of leading opinion-makers and legal scholars promises to provide a no-holds-barred discussion of the profound impact the impending November election will exert upon the membership and decision-making of the Supreme Court.

Participating panelists will include: Floyd Abrams, partner, Cahill Gordon & Reindel; William J. Brennan Jr., visiting prof. of first amendment issues, Columbia University Graduate School of Journalism; John McGinnis, professor, Benjamin N. Cardozo School of Law; Rep. Jerrold Nadler, D-NY-8th; David Schoenbrod, professor, New York Law School; Jay Sekulow, chief counsel, American Center for Law and Justice; and Nadine Strossen, professor, New York Law School, and president, American Civil Liberties Union.

DID YOU KNOW . . .

A presidential candidate must win 270 of the 538 electoral votes to win the presidency? Each state has a number of electoral votes equal to its number of senators and US representatives, and the District of Columbia is granted three electoral votes.

Originally, the Electoral College was designed to insulate the presidential election process from the people, and "electors," individuals who cast electoral votes for their state, were free to cast their votes as they chose regardless of the popular vote of their state.

Today, electors are bound by state law to vote for the candidate receiving the most popular votes in their state. With the exceptions of Maine and Nebraska, states give all of their electoral votes to the candidate who wins a majority of votes in their state.

Based on the current distribution of electoral votes it is possible to win the presidency by winning majorities in less than one-fourth of the individual states. The largest eleven states control 270 electoral votes. California (54), New York (33), Texas (32), Florida (25), Pennsylvania (23), Illinois (22), Ohio (21), Michigan (18), New Jersey (15), North Carolina (14), and either Georgia (13) or Virginia (13).

School weather closing policy

New York Law School has adopted the following policies if inclement weather forces class or examination cancellations. Also, remember that the latest information on closings is available on the NYLS hotline at 431-2111.

CLOSING FOR THE ENTIRE DAY

As long as the New York City Public Schools remain open, so will NYLS. The Law School will close if the public schools close. Occasionally, the public schools will announce a one-to two-hour delayed opening. NYLS will open at the normal time; there will be no delayed openings for classes or examinations. In the event of extreme weather conditions, members of the NYLS community are urged to listen to the radio to determine the status of the New York City Public Schools. This information is generally carried on 1010 WINS radio (1010 AM) and WCBS Newsradio 88 (880 AM). You also may determine the status of NYLS by consulting the WOR710 Radio website at www.WOR710.com.

If NYC public schools are closed for a holiday during severe weather, listen to 1010 WINS to determine NYLS's status.

EVENING CLOSING

If NYLS is closed for classes or exams during the day, it will automatically be closed in the evening. If NYLS is open for day classes or examinations but weather conditions worsen, students should listen to either 1010 WINS Radio or WCBS newsradio 88 starting at 3 pm to learn if the School will be closed.
