#### A MEMO FROM THE DEAN TO STUDENTS

I am hoping there will be many chances to meet with and speak directly to you. To help get this started, here are some ways to reach me that I hope you will find convenient and inviting.

My schedule for each week is posted outside the Dean's office, on the 2nd floor of A building. I have an open door policy—anytime I am not in a meeting and am in my office, you are welcome to drop by. # Laptop computer security

When using, transporting and storing your laptop computer, treat it as you would cash:

- ☐ Do not leave it unattended-even for a brief moment.
- ☐ When transporting, avoid placing the laptop on the floor or other surfaces.
- ☐ Back-up all important information periodically to ensure availability in the event of theft.
- ☐ Store it in a secure location where few persons would have access.

If at all possible, carry the laptop in a nondescript briefcase or padded backpack, and consider purchasing laptop security devices.
