# RICHARD MATASAR NAMED DEAN AT NEW YORK LAW SCHOOL, EFFECTIVE JULY 2000

Richard A. Matasar will become the 15th Dean of New York Law School, it has been announced by Arthur N. Abbey, Chairman of the Board of Trustees. Mr. Matasar, the Levin, Mabie and Levin Professor of Law at the University of Florida Levin College of Law, served as the dean at Florida's oldest public law school (1996-99) and was also Dean of the Chicago-Kent College of Law (1991-96). He will succeed Harry H. Wellington as President and Dean of NYLS, effective July 1, 2000. Dean Wellington will step down as Dean but will retain his post as rofessor of law.

"Mr. Matasar will bring his far-ranging legal, academic and management abilities to this institution as we embark on new ventures for the future," said Mr. Abbey, an alumnus of New York Law School and senior partner of the NYC-based law firm, Abbey, Gardy & Squitieri "He follows the dynamic tenure of Harry Wellington who has enhanced the academic reputation of New York Law School. This is an exciting era for our school: The faculty is strong, our student body diverse, and the curriculum as relevant and comprehensive as it has ever been."

Mr. Matasar was attracted to New York Law School, one of the nation's oldest independent law schools, for a variety of reasons:

"Since 1891, New York Law School has dedicated itself to excellence in legal education. Its outstanding graduates, dedicated faculty, and energetic students are committed to improving our profession, searching for justice, and moving legal knowledge forward."

A nationally recognized scholar in civil procedure and federal jurisdiction, Mr. Matasar served as the University of Florida Fredric G. Levin College of Law's ninth Dean. During his tenure at one of the ten largest law schools in the nation, he reated and implemented the school's first comprehensive trategic plan.

#### Part-time positions available

The Tort Division of the NYC Law Department, Office of the Corporation Counsel has part-time positions for day or evening students graduating in 2001. Students will work primarily on preparing cases in defense of the City in tort litigation. Part-time salary is \$14.19 per hour. Duties include: appearing in court under supervision, participating in discovery, participating in statutory hearings and performing legal research and writing. Appointees must be bona fide residents of NYC within 90 days of appointment. Good writing skills are required. Submit a résumé, one writing sample and a transcript to the Career Services.

In 1997, the AFL-CIO Lawyers Coordinating Committee (LCC), a network of 1,700 union-side attorneys representing AFL-CIO affiliated unions, launched the LCC Minority Outreach Program. The program encourages law students of color to apply for summer clerkships at union-side labor law firms and union legal departments. Now entering its third year, the Minority Outreach Program reflects the AFL-CIO's continued commitment to increasing the presence of minority attorneys in the labor movement. #### FACULTY ACTIVITIES

IUNCT PROFESSOR DANIEL ALTERMAN, the attorrepresenting the eight people arrested at a candlelight vigil for a slain gay college student last year, was quoted in *The New* York Times, Daily News, and Newsday newspapers in November. He discussed the lawsuit accusing NYC and the police department of constitutional rights violation.

PROFESSOR MICHAEL BOTEIN's chapter on "Auctions and Lotteries in US Media" appeared in a recent study on "Allocating Frequencies for Broadcasting" published by the Dutch Institute for Information Law.

PROFESSOR ANNETTE GORDON-REED's essay, "The Memories of a Few Negroes': Rescuing America's Future at Monticello" appears in Sally Hemings and Thomas Jefferson: History, Memory and Civic Culture. A collection of essays, the book focuses on the post-DNA Jeffersonian landscape. Prof. Gordon-Reed was on a panel at the conference of the Southern Historical Association discussing Jefferson and Hemings. Additionally, she spoke on "Southern Slave Law and the Legacy of Slavery," at the Mariners' Museum, Newport News, VA.

PROFESSOR LAWRENCE GROSBERG gave a talk on "Reform of the Bar Admission Process" at a conference of the ety of American Law Teachers on "Re-Examining the Bar Exam" in San Francisco in September. Last week, Prof. Grosberg and two Mediation Clinic students, Colette Foster-Franck and Stevie Griego appeared on a cable TV news program that profiled the Institute on Mediation and Conflict Resolution in the Bronx. The IMCR is a community dispute resolution center where clinic students are mediating cases.

PROFESSOR KAREN GROSS spoke on "Emerging Issues in Consumer Bankruptcy" at a Matthew Bender Program. Additionally, she was appointed an advisor to the Federal Judicial Center project on consumer debtors.

PROFESSOR JEFFREY HAAS recently published an article entitled "Tracking Stocks: What Directors Must Know" in the Nov/Dec. 1999 issue of *The Corporate Board*, on reserve in the library.

PROFESSOR ART LEONARD was quoted in a nationally syndicated *Detroit News* column concerning the Supreme Court's recent grant of *cert* in a pending family law case.

PROFESSOR CARLIN MEYER spoke at a conference on issues for women in the 21st century, particularly on an attempt obstitute rhetoric of intergeneration responsibility for that or personal responsibility. The topics discussed included childcare and eldercare responsibilities, as well as those of corporate and governmental entities toward future generations.

PROFESSOR STEPHEN NEWMAN's article, "Uses of Metaphor in Legal Argument," was published in the New York Law Journal.

PROFESSOR MICHAEL PERLIN spoke in Rochester to state Supreme Court judges and court attorneys on Kendra's Law, NY's new outpatient commitment law, as part of the state Office of Court Administration's Legal Update program. His article "Half-Wracked Prejudice Leaped Forth: Sanism, Pretextuality, and Why and How Mental Disability Law Developed As it Did," has been published as the lead article in a mental disability Contemporary Legal Issues. He also presented two papers on recent developments in seclusion and restraint law to an international symposium on mental health rights in Vallefield, Quebec. Additionally, as part of a workshop during Parents' Weekend at Wesleyan University (where his daughter is a freshman), he performed the clarinet part of a Beethoven duet with a member of the Wesleyan Chamber Ensemble.

PROFESSOR NADINE STROSSEN delivered the keynote Address, on Nov. 9, for the National Youth Leadership Forum on Law—a competitive program for high school students from around the country in Washington, DC. On Nov. 10, Prof. Strossen and 30 NYLS students attended oral arguments at the US Supreme Court in two important constitutional cases, involving issues of federalism, privacy, and free speech. On Nov. 12 and 13, Prof. Strossen delivered the keynote addresses at the annual banquets of the ACLU's Rhode Island and Florida affiliates, in Providence and Ft. Lauderdale, respectively.

PROFESSOR RUTI TEITEL was invited to be part of a select constitutional law discussion group at Georgetown University Law School on Dec 3. The discussion will focus on "constitutional canon." She contributed a chapter to a recently published book, *Deliberative Democracy and Human Rights* (Yale University Press).

His vision led to the development of several new research centers and an expanded international presence for the College. He anticipates that there will be changes at New York Law School:

"I am honored to follow Harry Wellington as Dean of this great law school. All of the building blocks are in place for moving the law school to the next level. I am dedicated to trying new things, pushing myself and my colleagues to experiment, take risk, and search for significant advances in legal knowledge. New York Law School is the future: a lean, agile institution that will embrace and adapt to whatever changes emerge in the next century."

## **Revised School closing policy**

New York Law School has adopted the following policies if inclement weather forces class or examination cancellations. Also, remember that the latest information on closings is available on the NYLS hotline at 431-2111.

#### CLOSING FOR THE ENTIRE DAY

As long as the NYC Public Schools remain open, so will NYLS. The Law School will close if the public schools close.

When the public schools announce a one- to two-hour delayed opening, NYLS will open at the normal time; there will be no delayed openings for classes or examinations. In case of extreme weather conditions, listen to 1010 WINS radio (1010 AM) to determine the status of the NYC Public Schools. If NYC public schools are closed for a holiday, listen to 1010 WINS to determine NYLS's status.

#### Evening closing

If NYLS is closed for classes or exams during the day, it will automatically be closed in the evening. If NYLS is open for day classes or examinations but weather conditions worsen, a determination about holding evening classes will be made by 3 pm.
