Media fellowships for students of color

Several paid media and telecommunications fellowships for the summer of 2000 are available to students of color with the Federal Communications Commission (FCC) and the National Association of Broadcasters, both in Washington, DC.

FCC fellows research and write in the area of communications law. They also attend various commission meetings with the commission's legal counsel or members of other divisions.

While students do not need to be work-study eligible to apply for a fellowship, they still must submit all necessary papers to Financial Aid to determine their eligibility. Submit to Career Services: four copies of a resume and a law school grade report. Deadline for second-year students: Wed., Nov. 17, 6 pm. The First-year student's deadline will be announced in January. Applicants are also required to sign-up for a Thurs., Nov. 18 interview. Note: While a grade report is part of the application, grades are not the paramount factor in selecting a fellow. Candidates should have an interest in the media and telecommunications field.

City Bar summer fellow program for first-year students of color

Each year the Association of the Bar of the City of New York conducts a summer fellowship program for first-year students of color. The program places students in NYC law firms. Within the next few weeks, Career Services will receive application materials from the City Bar and will notify students via e-mail. Applicants must submit official transcripts from the Registrar's office for graduate (if applicable) and undergraduate schools and a certified grade report from NYLS. Note: Interested students should request transcripts immediately.

Scholarships available for students

The special committee to administer the C. Bainbridge Smith Scholarship Fund has asked NYLS to nominate eligible NYLS students for these awards for the 1999-00 academic year.

These scholarships, ranging from \$1,000 to \$1,750 (or as determined by the scholarship committee), are made to needy law students who come from the five boroughs of NYC and who attend law schools within NYC.

To be eligible you must: be enrolled full- or part-time; and attended elementary and/or secondary school in NYC; demonstrate financial need; and face special disadvantages in meeting the cost of law school attendance. "Special disadvantages" include unusual hardship due to lack of funds, physical disabilities, or cultural handicaps. Students must complete the C. Bainbridge Smith scholarship nominee application and an information release authorization. For forms and information, contact Toby L. White, associate director of Financial Aid. Deadline: Application and release forms are due by Nov. 22.

FACULTY ACTIVITIES

PROFESSOR MICHAEL BOTEIN's short opinion piece, "Fee-Line Market Pressure," discussed potential telecom policy and antitrust problems with the Sprint/MCI merger. It appeared in the Nov. 1 issue of National Law Journal. The Dutch Institute for Information Law published his chapter on "Auctions and Lotteries in US Media" in a study on "Allocating Frequencies for Broadcasting."

PROFESSOR SYDNEY M. CONE, III moderated the symposium "Should the ABA Approve MDI?: A Discussion and Analysis of Multidisciplinary Practice" at the Association of the Bar of the City of New York in October. Sponsored by the "LS Center for International Law, the symposium also featured the past and present leadership of the ABA, representatives from European law societies, and professors. The symposium was also featured in Tax Notes. A symposium transcript will be available on the Center's website

"Reform of the Bar Admission Process" at a conference of the Society of American Law Teachers on "Re-Examining the Bar Exam" in San Francisco in September. Last week, Prof. Grosberg and two Mediation Clinic students, Colette Foster-Franck and Stevie Griego appeared on a cable TV news program that profiled the Institute on Mediation and Conflict Resolution in the Bronx. The IMCR is a community dispute resolution center where clinic students are mediating cases.

PROFESSOR MICHAEL PERLIN participated in an incompetency-to-stand trial evaluation conference with members of the Monroe County Socio-legal evaluation team. He presented a lecture to "The Journal Group" (local lawyers, judges and forensic expert witnesses) on the recent Supreme Court ADA decisions. He spoke during Michigan's State Department of Community Mental Health's Office of Recipient Rights' annual training conferences. He discussed issues of patient sexuality and the implications of the Supreme Court's recent decision in Olmstead v. L.C. on "least restrictive alternative" issues. He presented a formal version of the talk entitled "I Ain't Gonna Work on Maggie's Farm No More: Institutional Segregation, Community Treatment, the ADA and the Promise of Olmstead v. L.C" to a law review symposium at Thomas Cooley Law School.

PROFESSOR NADINE STROSSEN gave a public lecture in honor of Planned Parenthood's 70th anniversary on Nov. 4 in Cleveland. She addressed "Medical Privacy, Minors' Rights, and More." Prof. Strossen's most recent law review article, "A Comment on Redish and Kaludis's The Right of Expressive Access in First Amendment Theory," was published in the Northwestern Law Review.

PROFESSOR RUTI TEITEL's paper, "Vouchsafing Democracy: On the Confluence of Governmental Duty, Constitutional Rights, and Religious Mission," was published in the Notre Dame Journal of Law, Ethics & Public Policy, Issue No. 2, 1999.
