


Law in Tribeca Series: Racial Profiling Discussion

Racial Profiling: Before and After 9/11

Racial Profiling occurs when police investigate, stop, frisk, or search a person because of their race, ethnicity, nationality or religion. Best known is the stopping and searching of people of color for traffic violations, called "DWB" or "driving while black or brown." The tragic events of September 11 brought racial profiling to the forefront as Arabs, Muslims, and South Asians were removed from planes, held in detention, and targeted for

questioning and deportation by federal and state law enforcement.

The Law In Tribeca series will host a panel discussion featuring David Harris, Professor of Law at the University of Toledo and author of *Profiles in Injustice*, and speakers from the Campaign Against Racial Profiling of the American Civil Liberties Union; New York Law School; New York Civil Liberties Union; and the South Asian community. A reception and book signing will follow, with copies of *Profiles in Injustice* available for purchase.

The program, which is being co-sponsored by the New York Civil Liberties Union, the Campaign Against Racial Profiling-ACLU, and the Open Society Institute, is free and open to the public, but seating will be limited, so reservations are required. ## Holocaust Victim Assets Litigation Project Volunteers Still Needed!

The Office for Public Interest and Community Service at New York Law School and the ABA Law Student Division, through New York Law School representative Tiffany Almy, have decided to work together to promote volunteer efforts for the Holocaust Victim Assets Litigation Project established by the Brennan Center for Justice at NYU Law School.

The Holocaust Victim Assets Litigation (Swiss Banks) Project involves administration of a \$1.25 billion settlement reached on behalf of Holocaust victims seeking payment of their assets held in Swiss banks since the end of WWII in so-called "dormant accounts." Following worldwide notice of the settlement (notice appeared in 44 countries), 580,000 inquiries in the form of "initial questionnaires" were submitted by Holocaust survivors and their heirs and heirs of Holocaust victims who believed they might be eligible for payment under the settlement. The initial questionnaires ("IQs") have been scanned onto CD-ROM disks.

Volunteers are needed to evaluate the initial questionnaires for indicia of possible bank claims. Given the nature of the project and the availability of the CD-ROMs, the work can be done wherever there is computer access, and at the volunteer's leisure. The amount of time committed would be individual and flexible.

Approximately 10 IQs can be reviewed per student hour. #### **MFY Legal Services**

MFY Legal Services is seeking law students to participate in a project to provide employment-related legal services for low-wage and immigrant workers directly or indirectly affected by the World Trade Center disaster.

Additional opportunities are now available to work in this program run by the National Employment Law Project in cooperation with MFY Legal Services and the Legal Aid Society. The project works with labor and community organizations to educate their constituencies about the relevant legal issues—such as wage and hour standards, unemployment insurance and disaster unemployment assistance, and reemployment programs and benefits—and identify potential clients.

The project is available to 2L, 3L, or 4L students able to make a substantial commitment to participate during the spring 2002 term. Students will be trained to assist with client screening and intake and will assist in representation of clients in individual cases as appropriate, working closely with the supervising attorney assigned to the case. Employment law experience and second language skills are considered a plus.

The work of the project is expected to extend over the coming year, and there may be opportunities to continue this work over the summer. MFY Legal Services—which began in the mid-1960s as Mobilization for Youth—is a nonprofit providing legal support to at-risk and low-income populations.



#### Reporting from the Trenches: Physical, Corporate, and **Governmental Pressures on Latin American Journalism**

The Media Center will be presenting a panel discussion on Latin American news coverage Thursday, February 21, at 6:30 p.m. featuring as keynote speaker: Gerardo Reyes, Journalist, El Nuevo Herald. Admission is free.

Gerardo Reyes is a journalist and lawyer from Colombia. He was a professor of investigative journalism in several universities of Bogota. In 1988 he was hired by El Nuevo Herald, a sister newspaper of the Miami Herald. He worked as an assistant city editor and later was assigned to cover Latin America where he reported on major presidential elections, drug trafficking and corruption scandals. In 1999, he was transferred to the Miami Herald. He was part of the team awarded the Pulitzer Prize for investigative reporting. ("Dirty Votes, the Race for Miami Mayor"). Reyes returned to El Nuevo Herald in 2000 as a Latin American editor and currently covers Colombia, Venezuela, Argentina and Peru. Reyes is the author of the books Periodismo de Investigacion (Investigative Journalism) and Made in Miami: The life of narcos, saints, seducers, caudillos and snitches. Panelists include:

#### LAW & SOCIETY COLLOQUIUM

#### **Faculty Colloquium Looks at Urban Renewal**

Wendell Pritchett, Associate Professor of History at Baruch College and Visiting Professor at University of Pennsylvania Law School will be the first speaker this semester at the New York Law School Law & Society Colloquium Series on Friday, February 15, in the Wellington Center.

Professor Pritchett teaches and writes about urban issues and particularly race, community and politics in American cities. His book Brownsville, Brooklyn: Blacks, Jews and the Changing Face of the Ghetto is forthcoming with The University of Chicago Press. His paper for the workshop, titled "The 'Public Menace' of Blight: Urban Renewal and the Private Uses of Eminent Domain" examines the emergence of the urban renewal program. The paper argues that this movement's appropriation of the amorphous concept of urban "blight", which though facially neutral was infused with racial and ethnic prejudice, legitimized the redistribution of urban populations, which created additional obstacles to efforts to achieve integration.
