### Froessel Moot Court Competition Planned

The 1995 Charles W. Froessel Intramural Moot Court Competition, sponsored by the NYLS's Moot Court Association, will take place this month. The Froessel Competition enters its 19th year of providing students with the opportunity to write persuasive appellate briefs and engage in oral advocacy at its highest level.

The Froessel Competition is chaired by students Eileen McCrohan and Kurt Moody. Moot Court members earn academic credit, satisfy their writing requirement, and receive a variety of honors. They participate in intramural competitions throughout the year and sponsor the Robert F. Wagner Sr. National Labor Law Moot Court Competition.

All second, third, and fourth year (evening) students in good standing are eligible to compete in the Froessel Competition, including transfer students and anyone who has completed 20 credits. Froessel's top 16 competitors (the quarter-finalists), plus another 16 chosen on a discretionary basis, will win candidacy on Moot Court. The winners of the Best Brief, Best Team, and Best Preliminary Round Oralist awards will become candidates as well, regardless of their rank in the competition. The Froessel Schedule is as follows:

This year's Froessel fact pattern concerns two constitutional law topics: affirmative action and hate speech. Edited by the Moot Court Association, the fact pattern is written by; Larry Cowen, 1994 Froessel Octo finalist and winner of last year's Froessel's best preliminary round oralist; Alex Jeffrey, Chair of the Moot Court Association and 1994 Froessel Octofinalist; and Scott Segal, Vice Chair of the Moot Court Association and 1994 Froessel quarter finalist.

A prestigious list of judges will compose this year's final round bench. The seven final round judges are: Judge John S. Martin, Jr. and Judge John F. Sprizzo of the U.S. District Court for the Southern District of New York; Judge Joseph E. Irenas of the U.S. District Court of New Jersey; Judge James L. Oakes, Senior Circuit Judge for the U.S. Court of Appeals for the 1st Circuit; Justice Frederic S. Berman, Supreme Court of the State of New York; Dennison Young, Jr., Counsel to the Mayor of the City of New York; and Harry H. Wellington, Dean of New York Law School.

All are encouraged to attend the final round.

#### **Volunteers Wanted**

The New York Civil Rights Coalition is seeking the assistance of NYLS students to teach the Coalition's "Unlearning Stereotypes" program. The program takes place in over 40 New York City junior high schools and high schools. ### NYLS Welcomes Two New Professors

Two new professors have joined the NYLS full-time faculty.

Professor Ann F. Thomas, a former tax partner at Fried, Frank, Harris, Shriver & Jacobson, is teaching federal income tax. She received her J.D. from Yale Law School in 1976. During the past three years, she was a visiting lecturer at Yale Law School, a visiting scholar at New York University's Wagner Graduate School of Public Service and a fellow (affiliate) at the Mary Ingraham Bunting Institute at Radcliffe College. Professor Thomas' office is located in Room C310.

Professor Denise C. Morgan, who is teaching Civil Procedure and courses about education law, comes to the School from Cleary, Gotttlieb, Steen & Hamilton where she was a litigation associate. Prior to that, she was an assistant professor at Florida State Law School (1990-91). She received her J.D. from Yale Law School in 1990. Professor Morgan's office is located in Room C312.



### Faculty Activities

During the summer, **Professor James Brook** attended the week-long Advanced Quantitative Methods Institute for Law Professors held in Hanover, New Hampshire and organized by the Law and Economics Center of George Mason University School of Law. On another front, his book *Sales* and Leases: Examples and Explanations which was published by Little, Brown and Company last year, is already in use at over fifty law schools nationally. He is currently at work on a second book in the examples and explanations series; it deals with secured transactions under the uniform commercial code. He is eventually to complete the commercial law trilogy with a volume on payment systems.

On August 29, **Adjunct Professor David G. Samuels'** article, "Registration of Charitable Groups and Fundraisers" was published in the *New York Law Journal*.

Professor Lawrence M. Grosberg conducted a workshop last July on teaching lawyering skills at the Institute for Law School Teaching at Gonzago Law School in Spokane, Washington. The Institute holds an annual conference on topics relevant to law professors; it also publishes a newsletter and sponsors research projects relating to teaching.

Professor Nadine Strossen's interview, entitled "Tipping the Scales of Neutrality" (concerning the role of religion in the public schools) is featured in the September issue of *Rutherford*, the publication of The Rutherford Institute. On August 28, she gave a lecture at The College of William and Mary in Williamsburg, Virginia on "The Bill of Rights: The Original Contract with America." On August 29, she was interviewed for CNN's program "Show Biz Today" (concerning the sex business and pornography), which was aired on August 31.
